WE ARE NOT ALARMED.

Several friends of the JOURNAL have informed us during the past week, that our course in giving expression to our views on the paid organizer question will eventually injure this paper. We are sorry that any members of the association should desire to wreak vengeance on others because difference of opinion exists in regard to an act of the Grand officers. We regret that any brother should show such a pettychildish spirit; but our course will not be changed, even if such a spirit is manifested. We have expressed our opinion of the action of the Grand Board of Trustees, and we have invited other members to do the same. These columns have been open to them elsewhere. Is the position of the former class so weak that they must resort to threats instead of arguments to sustain it?

It would be far more pleasant to refrain from commenting on the appointment; but there are times when the most pleasant course is not the most conscientious, and 'tis better to break with every friend on earth rather than preserve friendship by acting the coward's part.




