# A DIABOLICAL PLOT.

DANNEMORA CONVICTS: FOILED IN A DESPERATE SCHEME

Several Keepers Would Have Been Murdered—Their Plans Divniged by a Fellow Prisoner, Who Would Not See Murder Done-Governor Flower Immediately Pardons Him.

ALBANY, July 18.—Walter N. Thayer, the warden of Clinton prison at Dannemora, came down to Albany late yesterday afternoon, and proceeding to the executive chamber related to Governor Flower a brutal scheme of a number of long term prisoners confined in his prison to gain their freedom, which included the coldblooded murder of several of the prison guards. One of the prisoners who was asked to enter into the murderous attempt to escape refused, and it was through him that the prison authorities became aware of the plot. The governor when he heard the facts immediately pardoned the prisoner who had the courage and manliness to prevent human slaughter.

At noon Sunday in Clinton prison as the prisoners filed through the prison corridor in lockstep on their way past Principal Keeper McKenna, to obtain their rations for dinner, one of the prisoners slipped into the hand of the principal keeper a piece of brown wrapping paper, two feet long by a foot wide, which was written upon on both sides in leadpencil and gave information in substance of a desperate plot of a number of prisoners to effect their escape. The communication went on to say that the doors of the cells occupied by two long term convicts, known as "Wright" and 'Reace," could be opened by the occupants and that the attempt would be made Sunday night. The two keepers on guard at the time were to have been murdered and five or six cells opened, liberating other convicts.

Warden Thayer told the governor that after the prisoners had finished with dinner the two prisoners referred to in the above communication were removed from Eddy of Buffalo had an arm and leg the woman who called at the same time as their cells, and an examination showed the truth of the prisoner's information.

The locks of the two cell doors had been tampered with as described. Hidden in the bedtick in Reace's cell was found a long sharp knife. 
