ON FIRST BALLOT.

Enthusiasm Ran High at the Convention.

All Candidates for the Lieutenant Governorship Remained in the Race to the Last Substantive of the Platform.

CONVENTION HALL, SARATOGA, Sept. 10.

—The nomination of governor and lieutenant governor by a Republican convention closed one of the most exciting campaigns of candidacy ever seen at a state convention. When the anti-Morton element found that they could not defeat the state candidate for governor they decided to force the nomination of a lieutenant governor.

It was decided by the anti-Platelement that to adjourn over night would be to give the supporters of Mr. Hendricks or Mr. Wadsworth a chance to change the result, which at the time of adjournment was in favor of Saxton.

The Fassett element and the others who were in to defeat any candidate for whom Mr. Platt might declare succeeded in balkling any lengthly recess and adopted the resolution for a two-hour recess.

At 4:45 every seat in the house was taken. The appearance of Mr. Platt also came in for a share of applause, but Mr. Hiscock did not receive a hand.

When J. Sloane Farnett walked up the aisle, just after the gavel had fallen, there was great and prolonged uproar of applause, the people in the gallery growing frantic.

At precisely 4:00 the convention was called to order.

Hon. Warner Miller was made permanent chairman.

From the committee on credentials Chairman Sutherland reported that they had heard a contest in the Albany Third district and had seated the Barnes delegation. When the question was put then was one "solitary negative." In the New York contest the committee reported through Mr. Sutherland as follows:

Mr. Sutherland—Mr. Chairman, further, your committee has had and considered a so-called contest from the county of New York. Your committee found instead of taking the nature of a contest, it took the nature of an appeal; an appeal to be let in. For some reason or other no reason was stated to the committee why the findings of the state committee here-to-for had not been entirely regular and correct. There was nothing before the committee to decide and the committee by a unanimous report in favor of the sitting delegates.

Mr. Sutherland was applauded, the applause being tempered by a few hisses from the Millholland faction, and then the report was adopted.

Mr. Miller was accorded to the platform amid plaudits.

Congressman Sereno E. Payne, chairman of the committee, reported the platform as arranged by the committee.

THE PLATFORM.

Declaration of Principles of the Repub-

lican State Organization.

The Republicans of New York in convention assembled extend hearty greetings to the Republicans of Pennsylvania, Rhode Island, Oregon, Vermont and Maine for their prompt and just judgment on an incompetent Democratic administration.

They rejoice the people that the path of protection is the path of prosperity. And we congratulate the Democratic party of Louisiana on their prompt and just judgment on an incompetent foreign policy established by James G. Blaine. If the God Army had been the badge of "bravery and brigandage," pledging retrograde dismemberment at the last session of congress, the expenditures of the corresponding session of the last Republican congress \$27,000,000 in the face of decreasing revenues, and after it had added \$50,000,000 to the public debt, while pre-

tending to be in favor of individual freedom it hastened to enact an odious income tax force bill, empowering deputy collectors to enter the homes of citizens and compel them by threats of official summons and heavy penalties to disclose their private affairs.

In this state, as in the nation, pledges are made to be broken. The Democratic party made its solemn pledge to consolidate state debts with unequal states, to reduce the tax rate, perfect ballot reform, strengthen electoral safeguards and establish home rule. Every one of the Democratic pledges have been disgracefully disregarded, while the Republican pledges have been honorably kept and especially those for the repeal of anti-home rule legislation and a reduction of public expenditures and diminished tax rate.
