5. The courts have decided that retaining or taking periodicals from the office, or removing and leaving them uncollected, are prima facie evidence of intentional fraud.
6. If subscribers pay in advance, they are bound to give notice at the end of the month if they do not wish to continue taking it; otherwise the publisher is authorized to send it, and the subscriber will be responsible until an express notice, with payment of all arrears, is sent to the publisher.

The latest postal laws are such that newspaper publishers can arrest any one for fraud who takes a paper and refuses to pay for it. Under this law the man who allows his subscription to run along for months unpaid and then orders it discontinued, or orders the postmaster to mark it "undelivered" and have postal card sent notifying the publisher, incurs himself liable to arrest and fine, the same as for theft.
