Auburn.

The Summer-Eve Musicals given by the Senior Circle of St. Mary's music class at Lyceum Hall last Thursday evening, attracted a large and appreciative audience, which showed the deep interest the friends of the Circle have in its progress, and the growing interest in Classical music among the younger musicians of the city. The Circle had been under the instruction of the Sisters of St. Joseph. Last evening's musicale gave evidence of artistic training and exceptional ability on the part of the instructors, and of marked talent on the part of the students. While not severely classical throughout, the programme gave place only to works belonging to the higher order of music. Rarely has a musicale been given here in which the participants were so proficient and so nearly equal as performed. Following is the programme, with names of participants.

An interpretation was given to each of the solos by Mr. P. Sheehan, as also an interesting history of the subject of the Overture Semiramide. A pleasing feature of the evening was the unveiling of a picture of St. Cecilia, the patron Saint of the Music Circle. The vocal numbers were especially acceptable, the voices were musical and sweet, the harmony true and rich. The audience were spell-bound throughout the rendering of the "Septuor" from Beethoven, arranged as a Grand Quartette for two pianos. In the Elocutionary number, "How Ruby played," Miss Helen Sullivan displayed remarkable powers of personation and description. In the concluding number a clarinet solo was rendered by Mr. Edward Hubbard, and the violin playing of Miss Margaret McConnell and Mr. John Stapleton received favorable criticism. In point of Art, the Musicals was a pronounced success and an event of the season.

FIFTY THINGS THAT EVERY CATHOLIC SHOULD KNOW.

WATERLOO, CONN.

1. The rules of his parish.

2. The chief truths of our holy religion.

3. How to bless himself properly and reverently.

4. That the beginning of wisdom is the fear of the Lord.

5. That God will render to every man according to his works.

6. That the influence of good example is far-reaching.

7. That the theological virtues are Faith, Hope and Charity.

8. That the Eminent Good Works are Alms-deeds, Prayer and Fasting.

9. That the Evangelical Counsels are Voluntary Poverty, Perpetual Chastity, and Obedience.

10. That the four Cardinal virtues are Prudence, Justice, Fortitude and Temperance.

11. That it is improper to gaze upon in church while the Sacred Mysteries are being celebrated.

12. That, if late at Mass, he should enter the Church, and take his seat as quietly as possible.

13. That it is proper to rent a sitting in Church and to pay for it regularly.

14. That to absent oneself from the Holy sacrifice of the Mass on Sunday or Holy days of obligation without sufficient excuse, is a grievous sin; and that persons, so negligent sin mortally the soul as early as God.

15. That the Sacraments are channels of divine grace instituted by the Lord Jesus Christ, and are seven in number, viz. Baptism, Confirmation, Penance, Holy Eucharist, Extreme Unction, Holy Orders and Matrimony.

16. That the seven Deadly or Capital sins are Pride, Covetousness, Lust, Anger, Gluttony, Envy and Sloth.

17. That the Virtues contrary to them are Humility, Liberty, Chastity, Meekness, Temperance, Brotherly Love and Diligence.

18. The Ten Commandments of God and the six Precepts of the Church.

19. Some pious reflections and exhortations to abstain from sin to those, especially in moments of temptation.

20. "The Angelus," a beautiful prayer recited three times daily in honor of our Immaculate Mother.

21. Some prayers to be said before and after meals, that gratitude for God's mercies should prompt him to his mercies.

22. The Lord's Prayer, the Apostles' Creed, the Acts of Faith, Hope, Charity and Contrition and the Confession.

23. That the Four Last Things to be remembered are Death, Judgment, Heaven and Hell. "In all thy works remember thy last end, and thou shalt never sin."

24. That the Seven Gifts of the Holy Ghost are Wisdom, Understanding, Counsel, Fortitude, knowledge, Piety and Fear of the Lord.

25. That the sins which cry to Heaven for vengeance are Wilful Murder, the Sin of Sodom, Oppression of the Poor and Defrauding Laborers of their Wages.

26. That the Sacred Scriptures are the inspired Word of God and are worthy of our profound respect and reverence.

27. That honesty is the best "policy" in spiritual as in temporal matters; but that "policy" should be synonymous with true virtue, enlightened and strengthened by conscience.

28. That the Ten Commandments are reducible to two, and that upon them depend the whole law and the prophets.

29. That marriages are not sacraments from the first Sunday of Advent until the Epiphany and from Ash Wednesday until Low Sunday; that Low Sunday is the first Sunday after Easter.

30. How to say "No" with grace when asked to transgress all laws of God or of the Church, or of his conscience.

31. How to say "Yes" cheerfully when invited to do good work, or the bestowment of alms, visiting the sick, teaching in Sunday schools, etc.
