### HILL TOOK A PROMINENT PART.

Resolutions Requesting Thacher to Withdraw Presented-Hill Urged That He Be Retained, Which Was Agreed to After a Very Bit-

tor Eight.

NEW YORK, Sept. 23.-Such conditions as confronted the Buffalo state Democratic committee when it met here have probably not existed in the political history of this state. The declaration of John Boyd Thacher, the nominee for governor, that he could not accept the entire national platform: the assertion of the Tamman organization that unless he accepted the platform that they would repudiate him; the contrary assertion of the gold men on the state committee that Mr. Thacher's attitude would pacify the gold men and gain more votes for the ticket; and last, but not least, the fact that in all this complicated skein of state politics, national polities and the Democratic national ticket ing of the people on a similar occasion in was involved, made men knit their brows and look serious. It was 11 o'clock when the fight over

Mr. Thacher was precipitated by the read ing of his letter addressed to Mr. Danforth and defining his position. The read ing of the document was listened to very attentively, and then John B. Shea of Tammany Hall introduced a resolution were fully 85,000 people who stood patientcalling upon Mr. Thacher to resign his nomination.

In an instant there was tumult. s dozen members striving to speak at once. The resolution was mild in terms and merely declared that Mr. Thacher, not be ing in sympathy with the platform, should not attempt to remain upon it as the candidate. Mr. Shea made a few remarks saying that the delegates to the convention at Buffalo had been grossly deceived and that Mr. Thacher could have given his views upon the financial question before the nomination had he intended to be hon-

When Mr. Shea, who was proxy for and represented Mr. Purroy, had finished, Senator Hill took the fluor, and there was almost deathlike silence as the senator began to speak in favor of the retention of Mr. Thacher upon the ticket.

Senator Thomas F. Grady replied to Senator Hill, beginning his remarks at 11:20 and not concluding until nearly midnight. He declared that Mr. Thacher could have averted all the trouble and criticism if he had been fair and square before the nomination was given to him. Tammany with 105 votes had been deceived by Mr. Thacher's friends, and he (Grady) had practically stultified himself with his speech of indorsement. The platform, he believed, should be repre-

BRYAN AT PHILADELPHIA.

The Nomines Receives the Greatest Ovation of His Tour

PHILADELPHIA, Sept. 88. - Mr. Bryan made his first campaign speech in New lersey at Washington park, a pleasure resort a few miles below this city. He spoke from the grandstand of the blogele track enclosure and a large crowd stood for over an hour and listened to him.

John S. Wright, the fusion candidate for congress in the First New Jersey district, presided. Mr. Bryan was greeted in this city by a

crowd which, according to the police and other authorities, exceeded any outpourthe history of the city.

He spoke at the Academy of Music. which has a seating capacity of about 8, 000. Every inch of space in the house and on the stage was occupied two hours before Mr. Bryan arrived and experts estfmated the audience at fully 6,000. Gathered in the street outside the academy ly until 10:30 p.m., hoping to see or hear he candidate.

The crush was something awful. Many of those who succeeded in getting inside the academy had their clothes almost torn from their backs. Many cases of more or less severe injury were reported, one man with a broken arm being taken to the hospital.

Hundreds of policemen were powerless keep the crowds in check. Mr. Bryan made his headquarters at the Lafayette hotel, two blocks above the Academy. In front of this over 8,000 people gathered desirous of getting at least a glimpse of the caudidate.

Since it was not possible for Mr. Bryan to make his way down Broad street to the Academy in his carriage, he was conductsd through the besement and kitchen of the hotel and out of the rear to a side street, through which he walked to the

Academy. He managed to make his way to the stage entrance and got inside after an experience with the crowd that he will long remem ber. When Mr. Bryan appeared on the stage

his reception was tremendous, the cheering lasting several minutes.

John L. Carlisle of Watertown and C. N. Bulger tried to modify the resolution and aid the Hill movement and before the vote was taken Senator Hill asked leave to speak again. This time, evidently provoked by the opposition, he gave some indication of his sentiment on the national ticket by saying:

"A man must not be condemned for disagreeing with the national platform. It has things in it that are in direct oppo-sition to all the Democratic tenets and be liefs. I have no objection to saying that there are things in the platform that no Demoorat can support. To say that you support the ticket is snongh." "Who will say that I must take upre-

servedly every line in the Democratic pistform? Who will say that Mr. Thacher. in order to accept the nomination for gov-ernor, must indorse every line in that platform? Are we to have a mine owner from the West come here and start a mag azine in the East to educate the people in Democratic faith?

Senator Hill went on to say that the Chicago platform was gotten up by Alt-geld, Tigman and others, who did not rep-resent the cardinal principles of Democra-cy. "Must we accept a platform proposed by such persons?

"Out upon such doctrines; out upon much principles."

Senator Grady arose to speak again, and this time his tone was more bitter and his remarks evidently pointed at Senator Hill. He said: "Yon, who talk regularity, you, who have used the lashes of regularity to whip us into line, who have cried; 'Be reg-ular, be regular' always, where now is your regularity?
