### OOBS SCRIPTURE ALLOW DIVORCE IN ONE CASE.

By Rev. P. H. Casey, S. J. (In The Messenger of the Sacred Heart)

(Continued from Last Week.)

In a word, unless our adversaries can prove from the texts in St. Matthew's gospel that an exception is made for adultery, when there is ques tion of dissolving the marriage tie, no such exception can be admitted.

The first passage on the question found in St. Matthew's gospel occurs in the Sermon on the Mount. But I qay to you that whosoever shall put way his wife, excepting the cause of fornication, maketh her to commit adultery; and he that shall marry her that is put away, committeth adul-(Mait. v. 32.) We are well ware of the existence of seven differ. ent interpretations of this text, each dine of which is an avempt to see ne le with the texts in St. Luke, St. Mark and St. Paul. Without expressly refuting any of these interpretations, we select the one which seems to us the traditional interpretati n of the Cathal. Church, and the one against which we believe no valid objection has ever yet been urged. it must be remarked that in the text

just quoted our Divine Lord says nothing about a man who puts away his wife and marries another. In the gospel of St. Mark, as well as in that of St. Luke, where no exception is made for adultary, there is ques ion of the man who puts away his wife and marries another. "Whoever shall put away his wife and marry another" says St. Mark. "Everyone that pu 'eth away his wife and marrieth another," says St. Luke. It is not the mere "putbirg away" that these two Evangeliate are writing about, but "the putting eway" that is combined with the taking of "another wife" Hence their language is absolute and they admit no exception. Now in the passage from St Matthew though there is question of a man puting away ha wife, there is nothing said about his marrying again. Consequently "the putting away" that is there spoken of oes not nece sarily me n "a putting away" that is combined with the dissolution of the marriage tie. We see how the other two Evangel sts distinguished be: ween "the putting away" of one's wife and "the taking of another." The presumption is that in the mind of St Maithew the same distinct on existed, and consequently, as he says nothing about the "taking another wife," he was not speaking of "a putting away" that g.vo p -mis loafor a second marriage. Therefore he was not speaking of the dissolution of the marriage tie.

It is n eless to object that "the Tows knew nothing about a l'mited fivorce, and that for them the phrase putting away" meant a discolution of the marriage bond. This assertion has never yet been proved. It seems, even on the face of things, abourd to say that a Jew never "put away" his wife excepting in circumstances where he considered himself free to contract a second marriage. Moreover, Christ was not laying down His law for the Tews or shaping it according to their enderstanding of things By the phrase "I say to you" He chowed He was enacting a law of the New Kingdom in which, as Protestants themselves must admit, there is a world of difference between "putting away" a man's wife and obtaining the privilege of mariyin again. Furthermore the words added by our Lord: "He that shall marry her that is put away committeth adultery," showed that the "puting away" of which he spoke left the marriage bond unbroken. Tha last clause of the verse is absolute. and neither logic, grammar nor good morals demand any exception to be supplied from the presious part of the sentence. If an excepti n were sup plied it would be in favor of a w man put away for adultery, and would confe. on her a pr vilege dealed to w m n put away for lesser offences. In this interpretation the law of Ch ist would be far laxer than the law of M. ses. for in the Mosaic law the pun shment of an adulteress was death.

We may now pass to the second passage in St. Matthew on which Profestants base their claim for absolute diworce in the case of adultery I say to you that who soever shal put away his wife, except it be for forn cation, and shall marry another, committeth adultery, and he that shall marry her that is put away committeeth adultery." (Matth. XIX. 9.)

From this text our opponents argue: "Whoever puts away his wife except for adultery, and marries another, is guilty of adultery: Therefore whoever puts away his wife for adultery and marries another is not guilty of adultery." This conclusion do s not follow. It is not warranted either by logic or by the grammatical construction of the first proposition. If such re-soning were admissible, the follawing would also have to be allowed. Whoever separates from his wi'e, except for a just cause, and ca'umniate. her, is guilty of u char'ty: Therefore, whoever separates from his wife for just cause, and calumniates her is not guilty of uncharity."
