Galway—On March 3, John King and his wife residing at Cloughmore, beyond Spiddal, were found dead in bed. Demonstrations were held in Galway March 9, over the unopposed election of Mr. Devlin as member for Galway. The Nationalist Independent Brass Band and the Forster Street Pipe and Drum Band paraded the streets followed by large crowds of people. Leitrim—James Nesbitt, who resided at Furnace, had a very narrow escape during the storm of February 28. About three o'clock in the morning a large chimney crock was swept from a portion of the house more elevated than where he slept. Although very heavy and very large it was swept for a considerable distance with such violence that, when falling, it came through the roof where he slept and fell on the bed in which he lay.
