A special feature of the legal department under the management of an expert lawyer where all branches of legal work are attended to, including settlements and adjustments.

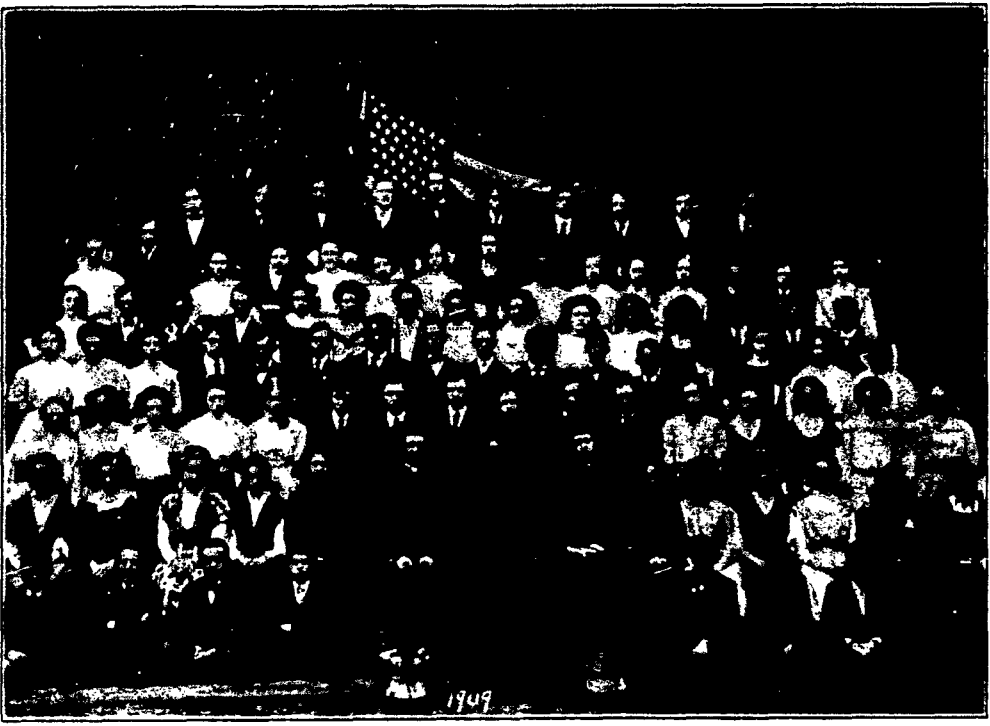

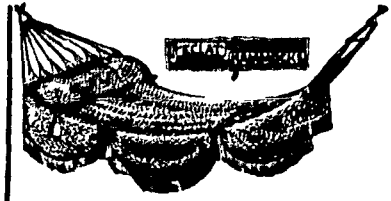

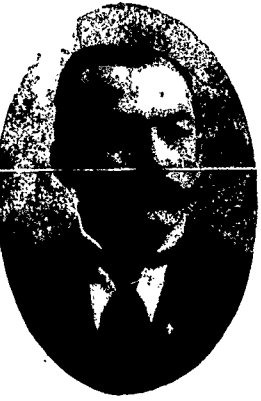
