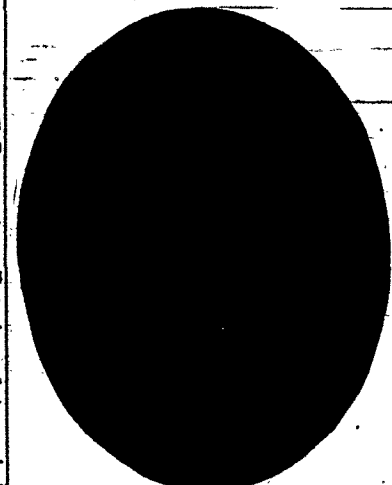
Alderman Cromwell is married and is the father of four children.—Adv.

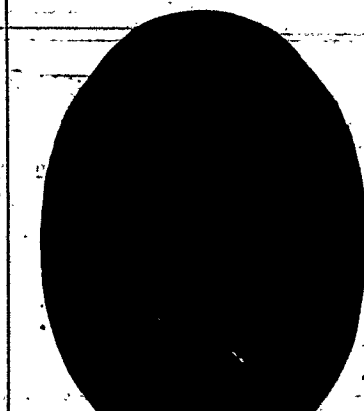
PETER W. SEILER.
