James A. Harris,
Republican Nominee for the Assembly,
First District.



James A. Harris, who was nominated for Member of Assembly on the Republican ticket in the primaries without opposition, has been a life long resident of the town of Penfield, where he owns and conducts a large farm, and is recognized as one of the leading progressive farmers of the county.

Mr. Harris is perhaps best known through the fact that he was School Commissioner of the First District of Monroe County three terms, being elected in 1902 and 1905 without opposition and in 1908 he carried every election district, running ahead of his national ticket.

Nominated for the Assembly in 1914, Mr. Harris received 4289 votes to 3,302 votes cast for Horace B. Warner, his Democratic-Progressive-American opponent. Speaker Sweet in 1915 appointed Mr. Harris a member of the following Assembly committees: Public Education, Public Health and Revision.

Mr. Harris introduced several bills. The High School Tuition Bill being one of the most practical. This bill provides cheaper tuition for Rural School pupils attending High School. Under the old law, parents of a child living in the Rural District and attending Fairport High School, as an example, would have to pay \$20 a year tuition. Under the Harris Bill, the State pays \$20.00 of that tuition and the parent only \$20.00.

The bill is State wide in its application. Mr. Harris also introduced a bill which gives Union School Districts of 300 pupils and over, the right by resolution of the Boards of Education in such Districts, to hold their annual school meetings in August instead of May, and the same Bill changes the time for holding the meeting for organizing the Boards of Education in three Districts.

Doubtless there are scores of young men who will recognize in the above picture Mr. Harris, the School Commissioner, who made his regular visits to the schools in the district where they were pupils in those schools. Adv.
