Two Editors, Women's Council Head Talk Rural Problems

Highlighting the second day's sectional meetings was the Rev. Joseph M. Campbell, president of the conference. Throwing a bomb, he was, a verbal bomb, Father Campbell attacked certain governmental institutions, among which is our present day banking system. He advocated setting up a "people's banking system" which is to be "based in structure and protection as far as human genius can the credit and deposits of the people."

Dr. O. E. Bick of the Department of Agriculture, a non-Catholic, in a marvelous presentation of statistics, cited the 20 per cent decrease in births during the last ten years as one of the most significant and alarming facts in our population trends. "The next few decades," Dr. Bick chimed, "are, in my opinion, years of grace for the American people. The people of the nation must see clearly the causes and consequences of the declining birthrate and resolutely set about to prevent them."

Visible Demonstration Is Given Catechists Aid Mexicans Fleeing From Persecution

By ALICE ROGERS - Graphic explanation of the method by which Federal, State and County organizations co-operate with local communities to foster the intellectual and physical development of rural youth was presented in the Story of 4-H Club program Monday evening, Oct. 28, by the National Catholic Rural Life Conference Convention. Addressed by representatives of the various units concerned in the planning and perfecting of 4-H work were supplemented by demonstrations of activities by boy and girl members of the club units from several sections of Western New York. Orchestral ability, the dancing of the quadrille, and halting-making were among the many abilities demonstrated to the audience by 4-H groups from Livingston, Wyoming; Genesee, Wayne and Monroe Counties.

Leaders in the co-operative movement, Frederick P. Kenkel, distinguished editor of Central Blatt and Social Justice of St. Louis, and Louis Witte of the National Co-operative Service Bureau at Nebraska, discussed the prospects of such institutions as a universal thing in the United States. Success of this endeavor will depend on Nebraska as an example. "All in all," said Mr. Kenkel, "the co-operative system" will be adopted to the great purpose to which our Holy Father has dedicated the Bi-centennial "Quingentesimo Annus" - the construction of a just and de-proletarianized of the masses. It undoubtedly aids the moral re-education of the nations and in need of, while it promotes at the same time their economic well-being. "The power however, which follows this concentration of wealth into the hands of those few who control it," Mr. Witte asserted, "gives those individuals and corporations unquestionably an almost exclusive right and power to distribute credit. It must be evident, to everyone that an equitable and just distribution of credit must be preceded by a concentration of this capital wealth, so that the power to distribute credit becomes immediately decentralized."
