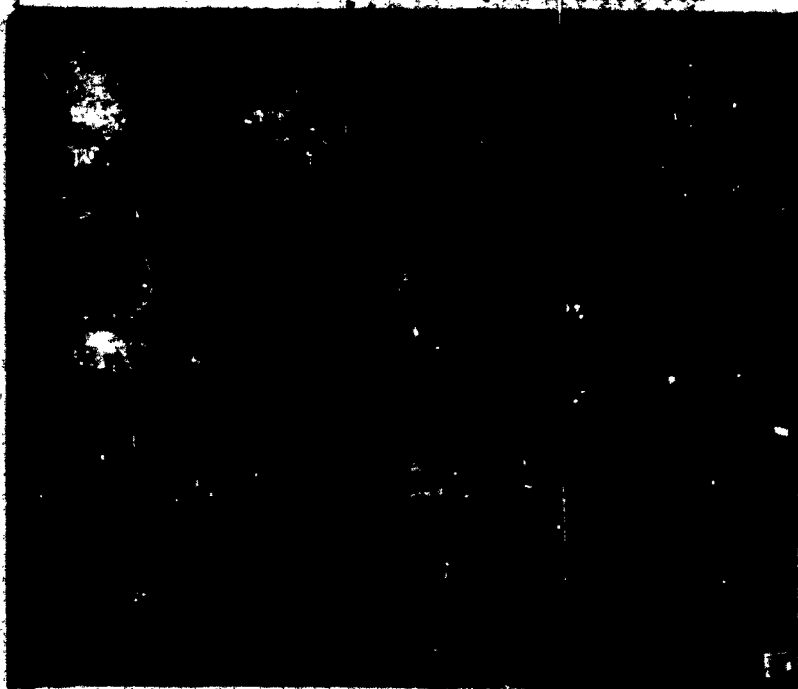


Red Cross Food for War Prisoners

The Post Office Department stated an opportunity was given for the appearance of representatives of both publications before the department's hearing board, but no representatives were present on the dates set for the hearings.

State School Bus Statute Declared Unconstitutional

SEATTLE (UG) — The Washington State Supreme Court has declared a 1937 statute which prohibited school buses from carrying passengers to ride in public places unconstitutional.

In January the Court, sitting en banc, had heard and argued the case. The statute in question was part of a series of laws designed to regulate school buses. The Court found that the statute violated the state constitution's guarantee of equal protection of the laws.
