Pope Given Copy of Biography of Founder Of Atonement Friars

VATICAN CITY.—(Radio, NC)—His Holiness Pope Pius XII was presented with the first copy of a new biography of Father Paul Francis, founder of the Franciscan Friars of the Atonement, whose general motherhouse is at Graymoor, N. Y. The presentation was made to the Holy Father by the Rev. Raphael Grande, S. A., former Superior of the Society.

Father Grande was presented to the Pontiff by His Eminence Nicola Cardinal Canali, who is Grand Prior of the Equestrian Order of the Holy Sepulchre, their church is Rome, S. Onofria al Gianicolo, is in charge of the Atonement Fathers.

The book presented to His Holiness bears the title "Father Paul of Graymoor" and was written by Father David A. Gannon, S. A., with a foreword by His Eminence Francis Cardinal Spellman, Archbishop of New York. Father Paul, an Anglican, was founder of the Order of Unity Octave. He, together with the entire community of friars and nuns at Graymoor, joined the Catholic Church in 1909.

Judge McGranery of Philadelphia, Named Papal Chamberlain

PHILADELPHIA.—(NC)—His Holiness Pope Pius XII has named Judge James F. McGranery, of the United States District Court here, a Papal Chamberlain of the Cape and Sword. It was announced by Bishop Hugh L. Lamb, administrator of the Philadelphia archdiocese and Bishop-designate of the new Greensburg, Pa., diocese.

The notification sent from Rome was presented to the Federal judge by Bishop Lamb. Last year, Judge McGranery was appointed a Papal Knight Commander of the Order of St. Gregory the Great at the same time his wife, Mrs. Regina C. McGranery, was awarded the medal Pro Ecclesia et Pontifice. The couple received the high honors from the Pope during a Holy Year pilgrimage to the Eternal City in company with the late Dennis Cardinal Dougherty, Archbishop of Philadelphia.

Judge McGranery was the guest speaker at the convention of the Catholic Laymen's Association of Georgia, held in Atlanta in 1944. At that time he was the Assistant to the Attorney General of the United States.

THE DEATH OF His Eminence Adam Cardinal Sapieha, Archbishop of Cracow, Poland, reduces the Sacred College of Cardinals to 49, and removes from the scene the only Cardinal behind the Iron Curtain who had been still free to carry on his ministry. The Cardinal, Poland's only member in the Sacred College, reportedly died at Cracow. He had been in ill health for a long time and was 84 years old.

WASHINGTON, D. C.—Monsignor Edward B. Jordan, vice-rector of the Catholic University of America, died here on July 19, after an illness of several months. Archbishop Patrick A. O'Boyle of Washington, Chancellor of the University, offered a Solemn Mass of Requiem at the National Shrine of the Immaculate Conception. Bishop Patrick J. McCormick, Auxiliary of Washington, delivered the sermon.

Monsignor Jordan had been a member of the university's faculty since 1921, and vice-rector since 1943. Previously, he had taught at Mount St. Mary's College and St. Joseph's College, Emmitsburg, Md.

WASHINGTON.—His Holiness Pope Pius XII has conferred the personal title of Archbishop on the Most Rev. Edward F. Hoban, Bishop of Cleveland, a member of the hierarchy for almost 30 years.

Archbishop Hoban has headed the Cleveland See since late 1946, when, as Coadjutor he succeeded to the See on the death of Archbishop Joseph Schrembs. Archbishop Schrembs at that time was the only member of the United States hierarchy heading a bishopric but holding the title of Archbishop "ad personam" or personally. Including Archbishop Hoban, there are now six such Archbishop-Bishops in this country.
