at Genoa. In 1922 he became a member of the faculty of St. John's College, taught Dantesque literature in the graduate school and also gave courses in government at St. John's University.

JUDGE MARCHISIO studied law at Fordham University Law School and in 1925 was admitted to the New York and Federal Bars. From 1928 to 1930 he lectured over the radio on law and political economy.

In 1937 he was appointed a Justice of the Domestic Relations Court in New York City thus continuing his work as an active and ardent fighter against juvenile delinquency having written, lectured and prepared many treatises on the subject.

He is a trustee of the Italian Board of Guardians, has been active on the Advisory Board of the Wiltoughby House Settlement, serves as chairman of the Protective Care Committee of the Catholic Charities, Diocese of Brooklyn and is Special National Field Commissioner of the Boy Scouts of America.

The Judge is a member of the New York County Lawyers Association, The Brooklyn Bar Association and the Catholic Lawyers Guild. By the Fall of 1944, a few months after taking up his active duties as President of the American Relief for Italy, he went to Italy to study and effect plans for relief distribution and, together with the Hon. Myron C. Taylor, Chairman of the Board of A.R.I., was instrumental in helping to create the National Committee for the Distribution of Relief to Italy (ENRDI) which became the official agency for the distribution of all relief materials from America.
