## John S. Maloney 200 Honor Father Guilfoil Rites In Elmira On His 35th Anniversary Conducted By Son

Coming — The Rev. Joseph V. Guilfoil, pastor of St. Vincent de Paul's Church, was the guest of honor at a surprise dinner at the Knights of Columbus Home given by approximately 150 of his parishioners and friends, the occasion being the 35th anniversary of his ordination.

Guest speaker was the Rev. David Gannon, S.A. of Graymoor Garrison, N.Y., who made a special trip to be present at the dinner. Father Gannon spoke of the many excellent things that Father Guilfoil has accomplished in the ten years that he has been in Elmira and paid particular tribute to the widespread charity practiced by Father Guilfoil.

INTRODUCED BY James Ward, toastmaster, were the Rev. William Reed and the Rev. Daniel Hogan, assistant pastor at St. Vincent de Paul's Church. Each, in turn, thanked the parishioners for their cooperation in making the dinner a success.

JUDGE MCGAREY OF BROOKLYN, Dies SURROGATE Francis D. McGarey of Brooklyn, who was the Column bus Day lay speaker for Rochester Council Knights of Columbus in 1948 died June 23, 1950 in his home city.
