

Diocese Collects 304,022 Pounds In Clothing Drive

The Thanksgiving Clothing Collection for the needy of the world, conducted in 136 parishes of the Rochester Diocese during last Thanksgiving week, amassed 304,022 pounds of clothing, bedding, and shoes, according to the final report issued this week by the Rev. E. Leo McManus, diocesan director.

Although 11 per cent less than the previous year's record collection, the recent collection constitutes the second largest total in the history of the annual clothing drives.

In issuing the report Father McManus expressed the gratitude of His Excellency Bishop Kearney to priests and people of the diocese for their consistent generosity.

THROUGHOUT the diocese 136 parishes, including two Ukrainian parishes, and two institutions participated. The largest parish donation in the diocese was that of Sacred Heart Cathedral, with 24,513 pounds of clothing contributed.

Of the participating parishes, 53 registered increases over their 1956 totals.

"Considerable as is the amount of clothing donated to the Thanksgiving collection," explained Father McManus, "the report does not include contributions which are made throughout the year by various parishes or by individual families to friends and relatives abroad."

"PARISHIONERS of St. Stanislaus parish in Rochester, for example, have sent abroad approximately 150 cartons of clothing independently of this collection. Nor does this report include the contributions of new clothing for infants and children to the Pope's Storeroms, a project of the Foreign Relief Committee of the Diocesan Council of Catholic Women."

Expenses of the shipment of the clothing to the Catholic Re-

lief Services - N.C.W.C. warehouses in the Bronx were borne by the individual parishes.

The Foreign Operations Administration makes available the ocean transportation of the clothing, and the actual distribution to the needy abroad is now being directed by the overseas Relief Services of the Catholic Relief Services.

Regents Committee Renames Msgr. Boyle

Msgr. Boyle represents all Catholic elementary schools in the eight dioceses of New York State on the committee.

T. Kane, Former Trustee, Buried

Corning - The funeral of Thomas Kane, retired Grwin Township farmer, was held Friday morning, Jan. 4, at St. Catherine Church, Addison with the Rev. Francis H. Turner, pastor, celebrating High Mass of Requiem. Interment was made in St. Catherine's Cemetery.

Mr. Kane a life-long member of the Addison church, died at the age of 76 the previous Saturday at the Corning Hospital where he had been a patient for five weeks.

He was a native of Ireland where he was born March 25, 1881.

Mr. Troy was a member of St. Catherine's Church, of which he served as a trustee for many years.

He is survived by five sons, Francis of Painted Post, RD 1, Michael of Addison, Joseph of Painted Post, Thomas T. of Freeman and Paul at home; also 14 grandchildren.

Ithaca Group Slates Showing Of 2 Films

Ithaca - A full program for members of Immaculate Conception Rosary and Altar Society is planned for Jan. 13. Movies will be shown and games played.

Priory Status Granted Mt. Saviour Monastery

Status of Mount Saviour Monastery, Elmira was raised to that of a Conventual Priory and the Very Rev. Damasius Winzen was appointed first Conventual Prior, according to word from Rome.

The decision marking the end of the first or "foundation" stage of the Benedictine monastery, was made by the Sacred Congregation of Religious, Vatican office handling matters pertaining to religious orders.

Mount Saviour becomes an independent member of the Confederation of Benedictine Abbeys throughout the world.

THIS OPENS the way for the next step, that of being raised to an abbey, in the monastery's development. This will take place when the monastery has met the necessary requirements consisting of a minimum number of 12 solemnly professed monks and the buildings which will enable the community to live the monastic life in full accordance with St. Benedict's Rule.

Necessary funds are expected through a campaign now being formulated to permit resumption of building of the monastic enclosure as originally planned. It was announced at Mount Saviour.

Since completing the first stage in the building plans in 1952, the Chapel of Our Lady, Queen of Peace, it was necessary to attend to the essential living requirements and postpone any further development in the original plans.

Mt. Saviour was founded in the spring of 1951, in the hills between Elmira and Corning, Father Damasius Winzen, the Prior, was the monastery founder and has been the temporary superior up to now.

His appointment as a Conventual Prior makes him permanent superior of the monastery and gives him the privilege of attending the congress of Abbots held in Rome every six years.

Mobile Chapels Serve Displaced

Koenigseln/Traunus, Germany (RNS) - Twenty-six mobile chapels operated by the Aid to Eastern Priests organization returned to their winter quarters here after having served nearly 100,000 Roman Catholic refugees and displaced persons in West Germany.

Missionaries accompanying the chapels included 121 priests from Germany, Belgium, Holland, Austria and Spain. They visited 442 communities, gave Communion to 72,242 persons and heard 28,899 confessions.

Each mobile unit is supplied with an altar and loudspeaker and has storage space for relief supplies that are donated to needy Catholics.

The Aid to Eastern Priests organization is a Dutch-Belgian group founded in 1948.

Elmira Sisters Of Mercy Launch Drive To Reduce High School Debt

Elmira Sisters of Mercy will launch a debt-reduction campaign at the kickoff dinner to be held at Notre Dame High School cafeteria on Tuesday, Jan. 14. The Sisters plan to reduce the \$750,000 debt on the new Notre Dame High School. This project has the authorization and blessing of His Excellency Bishop Kearney and His Excellency Auxiliary Bishop Casey.

Monsignor William J. Brien, V.F. will speak at the dinner. The planning committee, together with captains and workers, will hear the Rev. Joseph F. Hogan, chaplain of Notre Dame High School, expound the purpose of the January fundraising campaign. Co-chairmen Theodore LeBrecque and Bert Seifried will further explain the drive, issue work kits and direct the line of action.

MOTHER MARY MAGDALENE, mother general of the Sisters of Mercy will be present to outline the financial status of the community and urge Elmiraans to cooperate in the urgent need for funds.

In September 1955, Notre Dame opened its doors to 341 high school students at the total cost of \$1,508,500. Of this amount \$611,000 was raised by pledges from the people of the Elmira area. It was, therefore, necessary for the Sisters of Mercy of the diocese to assume a debt of nearly one million dollars. Through their sacrifices and careful management that debt has been reduced to \$750,000.

The carrying of the debt remains necessary since tuition received from the 492 students now enrolled shoulders only the running expenses of the school, not the principal and interest on the debt, according to the Sisters.

TO EQUIP additional rooms and maintain school facilities boosts considerably yearly expenditures and leaves no available money for debt reduction or payment of interest.

Since a further need for funds to finance the building of a teacher-training college for the Sisters of Mercy and the expansion of living accommodations

for the young aspirants is required, friends of Notre Dame are being asked to lighten the Notre Dame debt. Only by reducing the Elmira debt can the Sisters hope to carry on their new building project to meet state requirements.

General solicitation for the drive will take place between Jan. 14 and 29 when the final report will be given. The first report will be submitted by the captains at a meeting on Jan. 20.
