## PITTSFORD GROWING UP TO 615 FT. ABOVE SEA

### St. Louis Parish Subdivision Being Developed By Ben Levin

Hailed as the largest residential subdivision with sanitary sewers, as well as having the highest elevation of any tract in Pittsford, Ben Levin's "Pittsford Heights" was officially opened for development last week.

The 75 acre parcel running from South Main Street (Pittsford) beyond Jefferson Road, over the village "water tower hill", and down the eastern slope to the Jefferson Avenue curve, comprises 150 large lots.

Considerable interest has been evidenced from Catholic families seeking homes conveniently located near the new St. Louis Church and Parochial School, according to Mr. Levin who is about to build on 40 lots at the South Main Street entrance at Hilltop Drive. Storm sewers have been installed sufficiently deep to eliminate the need for sump pumps in basements, he pointed out.

The introduction of "Pittsford Heights" to homeseekers ends three years of planning by Ben Levin who visioned a restricted tract in Pittsford complete with sanitary sewers.

The completion last week of final arrangements for the Pittsford sewer system and the operation of a town-owned disposal plant may mark a most decisive step forward in the development of Pittsford in keeping with the high calibre of its present residents, according to Edward D. Seward, town supervisor.

To maintain the present high standards, rigid building restrictions will be enforced, Seward stated, and added that, coupled with the new sewer system, the fact that the town offers the lowest tax rate in the county accounts for the prevailing surge in home building plans in Pittsford. There are presently only 1.08 residents per acre on the town's total of 14,720 acres.

Ben Levin, owner, developer and builder of Pittsford Heights is best known in the city of

Rochester through his purchase of many of the fine old homes along East Avenue thoroughfare since the end of World War 2. Without sacrificing their appeal of grandeur and seclusion, Mr. Levin converted them into apartments for the semi-retired and for business and professional couples. The grounds are carefully maintained.

Among the best known of his holdings, in proximity to the Diocesan House, residence of His Excellency, Bishop Kearney, and the famous Eastman House, are: the former Bonbright mansion, 950 East Avenue (8 apts), the former Hollister homestead, former Alling home, 901 East 857 East Avenue (45 apts.), the Avenue (3 apts.), the Dirlinger home, 963 East Avenue (3 apts.), and the old Antishe home, just off East Avenue on Culver Road.

### Diocese Beneficiary Of Hickey Estate

A sum of \$10,286 was bequeathed to the Diocese of Rochester in the will of Constance J. Hickey of 2109 St. Paul St., made known last week. Another \$10,286 was left to the Rochester Community Chest the estate amounted to \$417,500.

The bequest to the diocese requested that it be used by "Bishop James E. Kearney, or his successor, in confidence that he or his successor will keep in mind educational institutions in the Diocese in which my husband and I have been interested."

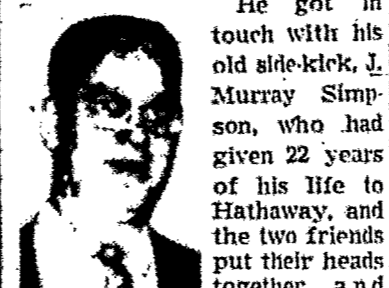
Many observant people have noted how different businesses have started there, struggled for awhile, and finally gave up.
