

the home three times to complete the couple's background as to history, health, work, home conditions, likes and dislikes. She will ask the couples parents and inquire if there is any disease or mental illness in their background. She will try to decide whether they will make good parents by this personal contact.

A financial statement is obtained and bank accounts and insurance policies must be certified. A complete setup in "home study" as to the number of rooms, size etc. is made. Their references have to be 1 Protestant and 3 Catholics.

Usually 3 references are given and then the caseworker will decide the 4th as to an impartial opinion. She will also make personal visits to the pastor and doctor in addition to the evaluation papers mailed them.

The entire case is then presented to the adoption board under a fictitious name. The
