Geneva — Major William C. Flannigan, formerly of 18 Universal Ave., is one of seven officers of the Air Force Academy to be chosen to spend several days as guest observer aboard units of the Pacific Fleet off San Diego, Calif.

MAJOR FLANNIGAN will be flown from Colorado Springs to San Diego where he will first board the USS Bon Homme Richard, one of the carriers attached to the Pacific Fleet. Later in maneuvers, he will spend some time aboard one of the fleet-type submarines.

Nazareth Grad Featured By National CSMC

Miss Jeanne Doscher, a 1960 graduate of Nazareth College, is the author of an article, "Collegians Go Sweeping Down the Plain, in the January, 1961, issue of The Shield, the Catholic Students Mission Crusade magazine.

Miss Doscher was one of a group of 43 collegians (eleven from Nazareth College) who, spent the summer working in Oklahoma, taking a religious census and teaching catechism, in the diocese of Oklahoma City.

Armed before leaving the East with only a geographical knowledge of Oklahoma, which "conjured up images of Indians, snakes, cowboys and tepees," she confesses to a feeling of relief at finding it a modern state, and her working territory of the town of Chickasha (chosen because it sounded primitive) as modern as any town in America.

The people, she reports, were warmly sincere and hospitable, but in predominately Non-Catholic rural areas, most un-familiar with Catholic doctrine.
