State Law On Texts **Upheld**

Washington, D.C. - (RNS) - The U.S. Supreme Court, by a vote of 6 to 3, upheld a New York law which requires that local public school authorities loan certain textbooks free of charge to all students in grades 7 through 12, including those attending parochial and other private schools.

The landmark ruling maintains that the Establishment Clause of the First Amendment does not preclude states "from extending the benefits of state laws to all citizens without regard for their religious affiliation . . ."

Main thrust of the ruling rested on Everson v. Board of Education (1947) when the Supreme Court ruled that New Jersey could not be prohibited "from spending tax-raised funds to pay the bus fares of parochial school

Justice Byron R. White, in delivering the majority opinion, admitted that the Everson Case and subsequent ones "have shown that the line between state neutrality to religion and state support of religion is not easy to locate.'

The Court ruled that in providing secular textbooks to children in nonpublic schools, New York State was exercising a legitimate concern for the education of all its children.

"We are unable to hold - . . that this statute results in unconstitutional involvement of the state with religious instruction or that (the law), for this or the other reasons urged, is a law respecting the establishment of

The opinion said the appellants, the Board of Education of Central School District No. 1 in Greenbush, N.Y., "have shown us nothing about the necessary effects of the statuste that is

contrary to its stated purpose."

The law, the decision continued, "merely makes available to all children the benefits of a general program to lend school books free of

Books are furnished at the request of the pupil and ownership remains, at least technically, in the state, the opinion said. "Thus, no funds or books are furnished to parochial schools, and the financial benefit is to parents and children, not to

Justice White's opinion maintained that the express purpose of the New York law, as set by the state legislaturé, is "furtherance of the educational opportunities available to the

White summed up the significance of this approach this way:

"Underlying these cases, and underlying also the legislative judgments that have preceded the court decisions, has been a recognition that private education has played and is playing a significant and valuable role in raising national levels of knowledge, competence and experi-

"Americans care about the quality of the secular education available to their children. Considering this attitude, the continued willingness to rely on private school systems, including parochial systems, strongly suggests that a wide segment of informed opinion, legislative and otherwise, has found that those schools do an acceptable job of providing secular education to their students."





Diocesan Foundation Of 2 New Parishes Reflection of Growth

The appointment of pastors for the immediate establishment of two new parishes in the northwestern sectors of the diocese reflects rapid suburban growth in Chili, Gates, Spencerport and Coldwater, the Pastoral Office said today in announcing that Rev. Elmer McDonald of St. Augustine's and Rev. John Steger of St. Theodore's were given pastoral rank.

Both new areas are so far untitled and undefined by specific boundaries, the Pastoral Office announced, but will be formed from border sections of St. John the Evangelist of Spencerport, St. Pius of Chilli, St. Theodore's of Gates, Holy Ghost, Cold-

New Laity Action Plan In Trouble

London-(NC)-A campaign of the bishops of England and Wales to enlist the advice and talent as well as the money of the laity to strengthen the operation of the apostolate has been the subject of criticism, particularly the way in which the plan was

The London Catholic Herald said (June 7) that "the much-heralded experiment in lay participation must go on record as being only a partial

The campaign, called New Pentecost, began in June. At that time all adult Catholics received a card on which they were asked to state what talent or skill they could offer the Church. Certain laymen and laywomen spoke that same day in pulpits throughout the country urging their fellow Catholics to take a much greater share in Church administration. Twelve commissions of the laity and clergy have been set up by the bishops on a consultative basis to deal with every aspect of Church

The Catholic Herald, in its assessment of the movement, estimated that two of every three parish churches had lay preachers speaking on the campaign. It said that cases in which the laity did not appear were due as much to irritation on the part of the laity as the clergy.

The sermon cited the Second Vatican Council's concern for the active participation of the laity in the work of the Church.

In addition to asking for money, the lay preacher urged commitment and appealed for the time, enthusiasm and active help of other laity. They said the Church in England and Wales asks "us to be generous with our resources and ourselvesin a New Pentecost which will be a renewal of the work of the Apostles that began at that Peniecost in Jerusalem."

church since 1944. There is no rectory but Father Kenny said he has begun a search for a small home near the church. Speaking of his new parish, Father McDonald said, "We really don't know how many families there will be since parish boundaries have yet to be staked out. We do know that

The Pastoral Office today announced the retirement of eight pastors of the diocese, the establishment of three parishes with resident pastors, the assignment of 16 priests to new pastoral responsibilities and changes of duty affecting 18 other priests.

The 10 newly ordained priests, still on vacation, will not be given their assignments until next week. All the appointments and retirements. will be effective at 6 p.m. Thursday,

Auxiliary Bishop Dennis W. Hickey will relinquish his parish of St. Theodore, Gates, on the 27th and will take residence in a private house in Rochester. But Auxiliary Bishop John E. McCafferty will not be moving from Holy Rosary parish for two more months, the Pastoral office announced.

In releasing this year's appointment list, Bishop Hickey stated that the Priests' Council played an important role in the formation of the roster. "The Council reviewed the entire slate some 10 days ago," he said, "They made comments and suggestions which were followed by the Bishops before approaching every single man on the list."

Three of the retirements are for reasons of age: Monsignor Robert Keleher of St. Charles Borromeo, Monsignor John F. Duffy of St. Augustine's, and Monsignor John F. Neary of St. Michael's, Lyons.

Retiring for reasons of health are Monsigner Maynard Connel of St. Margaret Mary's, Monsignor Edward J. McAniff of Blessed Sacrament, Rev. Albert Geiger, Holy Ghost, Coldwater, Rev. Jacob Rauber, St. Leo's, Hilton and Rev. William J. O'Brien, St. Patrick's, Moravia.

Monsignor Connell was rector of St. Andrew's Seminary when he was pointed, in 1956, Mary's, Irondequoit. He had taught literature and homiletics at the minor seminary and at St. Bernard's for 18 years and had been rector of St. Andrew's from '50-'56. He was widely known for his preaching skill and radio talks on "Church of the Air" and "Catholic Hour."

Ordained in 1927, he spent two years in parish work, then studied at Cornell University, earning the Master's and Doctor's degrees in literature. He was associated with the Church of the Nativity of the Blessed Virgin, Brockport; St. Mary's, Canandaigua, and Immaculate Conception, Ithaca at the beginning of his priesthood, and during his years of teaching served weekends at Blessed

Monsignor Duffy was appointed pastor of St. Augustine's in 1945; after 16 years as diocesan superintendent of schools and director of the Confraternity of Christian Doctrine. A 1912 graduate of the Oswego Normal School, he had taught in the public schools of Corning for several years before undertaking studies for the priesthood.

A year after his ordination from St. Bernard's in 1923, he was assigned to the faculty at Aquinas Institute, and taught there three years. His early parish assignments, were at St. Anthony's, Rochester, and Holy Family, Auburn. He was elected to the Diocesan Priests' Council last
