Bishop-designate to Officiate At Church Groundbreaking

Bishop-designate Joseph L. Hogan will officiate at groundbreaking ceremonies for the proposed St. Christopher Church building, North Chili, at 4 p.m. Sunday, Oct. 26.

Father Elmer McDonald, pastor of the new parish established in June last year, said construction will begin immediately. He hopes for occupancy by next summer.

Masses for the 500-family parish now are being celebrated in the North Chili Medical Building. Religious instruction for parish children is being held in the First Methodist Church building and in the St. Christopher Rectory basement.

Father McDonald pointed out that the proposed structure, to be erected on a 15-acre plot at Union and King Streets, just south of Buffalo Road, will be a "multi-purpose building designed to meet the needs of a parish in a changing world."

Through use of folding doors, the building can be used totally as a church seating 600 persons, as an assembly hall seating 400, or can be divided into two large meeting rooms or five classrooms

For purposes other than worship the sanctuary area is protected by a

"We no longer think of a church . building as a worship center used one day a week or one hour a day, and lying idle for the remaining time," Father McDonald said. "Today's church is oriented to the action of today's pace and functional require-

Entire cost of the project, he said, will approximate \$250,000, including

fees, landscaping and complete furnishings.

The building will be at the corner of Union and King Streets, and will be set back to show the roofline to best advantage. The parking area will accommodate 400 cars.

Designed in circular form, the building features a swooping roof starting low and rising to a cylinder type of structure over the sanctuary area. The ceiling will be of natural redwood planking, the low walls will be white plaster and the sloping side walls natural cedar shingles.

The effect from inside will be of an ever-increasing height climaxing over the altar, with a large skylight at top. There will be shingles and


He was named assistant superintendent of diocesan schools the following year, and at his appointment as superintendent he was at 36 the youngest in the diocese to have undertaken
