## Bishop Hogan Helps MDA Campaign

Linking personal pain with the sufferings of Christ, Bishop Hogan last week added his support to the telethon appeal for the Muscular Dystrophy Association.

Stating that "the presence of illness in the world is not only a challenge to the heart of man but also to his intelligence," Bishop Hogan stated:

"The Lord challenges us to apply our minds to a solution of human miseries. He has given us the dignity of being His instruments in making this a better world. Most of us lack the scientific ability to meet the challenge—but our generous hearts can support the minds and hands of those who have this blessing."

Christian theology, the Bishop said, "judges the health of a man by his measure of charity. Charity is described as the greatest human endowment be-

cause it dilates the human heart and spirit—brings man out of the narrow and constrict-

ing confines of self and extends his world to a vision of the needs of all men."

## Porno Report Delayed By Dissenting Member

Washington, D.C.—(RNS)—A dissenting member of the Presidential Commission on Obscenity and Pornography has won a court order that temporarily blocks publication of the commission's controversial findings.

Federal District Court Judge Oliver C. Gasch granted a 10-day restraining order to Charles H. Keating, Jr., a Cincinnati lawyer who is President Nixon's only appointee to the 18-member panel.

In his suit, Keating complained that he had not been given sufficient time to file a dissent. Commission chairman William B. Lockhart, dean of the University of Minnesota law school, had requested that a dissent no longer than 150 typed pages be filed by 5 p.m., Sept. 10.

The commission's report, much of which has already leaked out, reportedly concludes that pornography has no rela-

tion to crime or sexual deviancy.

The report's most disputed recommendation is to repeal all laws pertaining to "consenting adults" who want to obtain sexually oriented films, books or pictures.

Of the 18 commissioners, 10 voted for the recommendation without qualification. Two gave qualified assent and six expressed varying degrees of opposition.

Judge Gasch has set a hearing for Sept. 18 to determine whether the report should be withheld for a longer period to give Keating time to study the commission's final draft and also some of the 10 volumes of research reports that total 10,000 printed pages.

The fate of the report is in doubt since the commission expires on Sept. 30. Unless the report is prepared for release by that time, it stands a chance of ending up on a shelf.
