FIRST DIVORCE IN ITALY

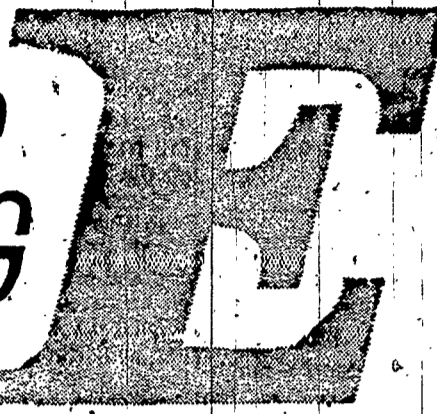
