### Drug Crisis Center Proposed Here

Legislation that would create a Drug Abuse Crisis Center in Rochester has been filed in Albany by Sen. Thomas Laverne and Assemblyman William Rosenberg.

The center would be operated around-the-clock by a professional staff and would be directed to the teen-age drug user.

The services provided would include 24-hour open phone lines for crisis calls, consultation with staff members at the center as well as with outreach workers throughout the community.

The proposed Rochester Crisis Center would be funded by the State as a demonstration project and carries with it a \$150,000 appropriation for establishment of the facility.

Laverne and Rosenberg say the creation of such a center was first proposed by Dr. Martin Wasserman of Rochester, a member of the Monroe County Narcotics Guidance Council, who outlined his plan during a public seminar on drug use at Eastridge High School last September.

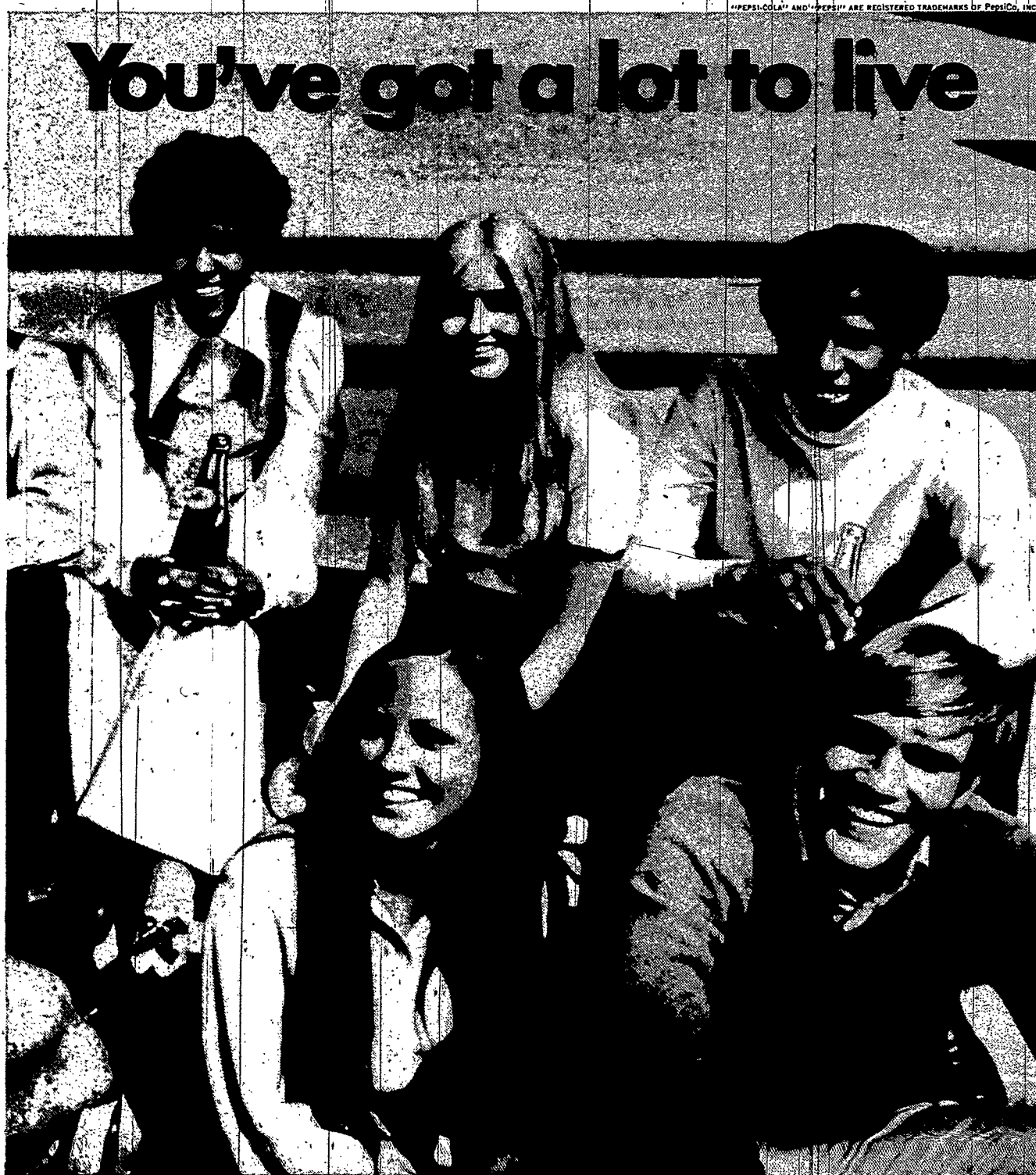
