tion, 'liberation from' movements, and automated answers to human problems.

How easy it becomes for us to transfer this worldly philosophy of the "good life" to our own spiritual life—to espouse what might be called an I.B.M. spirituality. This false asceticism would advocate instant redemption assured to all who could feed into the programming of their lives an impressive record of numbers of devotions attended, prayers uttered, and Communions received. And the best this computerized approach to Christianity could ever read in its summary and analysis of our spiritual health would be: "He loved the Redeemer but not His Cross."

It is, then, with the vigilance of a good mother's concern for her children's well-being, that the

Church sets aside a definite period each year to help us absorb the wisdom of the cross of Christ and to learn what He meant when H offered this season's invitation: "Let us go up to Jerusalem." For who of us would embrace the Cross on his own initiative? And even if our faith were strong enough to remind us that there is but one road to the Heavenly Jerusalem, painful because it is an upward journey, when would we begin the ascent? Most likely on some tomorrow—that elusive moment which always avoids the unpleasant reality of now—the only time the Lord has called 'acceptable'.

Lutheran Tells Of Visit to Pope Paul

Minneapolis — (RNS) — Dr. Fredrik A. Schiotz, former president of the American Lutheran Church, had a private audience with Pope Paul VI and thus filled what may have been the only gap in his long career of ecumenical relationships.

On his way home from the late January meeting of the Central Committee of the World Council of Churches in Addis Ababa, Dr. Schiotz accepted Vatican hospitality for the first time.

Dr. Schiotz, who was also president of the Lutheran World Federation for seven years, had not visited the Pope before, feeling that constituents might misunderstand his visit

State 'Services' Aid Headed for Schools

Parish schools and high schools of the diocese will begin receiving checks totaling 8678,734 from New York State next week to pay for state-required secretarial services supplied by the Schools.

First mailings of the payments to 104 schools in the diocese.— part of \$10.1 million being paid to 1,365 nonpublic schools throughout the state—should arrive in the next 10 days, according to John Ritzenthaler, diocesan comptroller.

(A listing of the appropriation given to each school will be printed in the Courier-Journal next week.)

Ritzenthaler announced that this month's state checks are only half of what the schools of the diocese will receive this year. An equal amount, bringing the full total to nearly \$1.3 million — is expected "by late May or early June."

Schools receive \$27 a year for each elementary school pupil and \$45 for each high schooler enrolled.

Abortion

Repeal Defeated

Santa Fe, N.M.—(RNS)—Efforts to repeal or amend New Mexico's liberal abortion law have failed in the current session of the legislature.

The House committee considering a bill setting numerous restrictions on abortions gave it a "do not pass" recommendation.

More than 700 abortions were performed in New Mexico in the year following the liberalized law's passage. Only 70 legal abortions were performed in the year prior to enactment of the law.

Move Fails

Annapolis, Md. — (RNS) — A parliamentary maneuver designed to kill a liberal abortion bill in the Maryland House of Delegates was defeated here. The amendment would have required a three-fourths majority to pass the new abortion measure.

As written, the bill would make abortions before the 20th week of pregnancy a matter to be decided by a woman and her doctor. After the 20th week, the operation could be done only if judged necessary by the physicians.

Father Leon Hart, associate superintendent, necessity for passage of the bill at this session.

Carmen J. Viglucci, editor of the Courier-Journal, was named chairman of the committee and John Oberlies of St. John of Rochester Parish, Fairport, vice chairman.

The bill would provide direct assistance to parents of students enrolled in nonpublic schools.

Before it can come to a floor vote, the education committees must vote to release it. Sen. Thomas Laverne of Irondequoit is chairman of the Senate Education Committee and Mrs. Constance Cook is the Assembly committee chairman.

Gov. Rockefeller had indicated his displeasure with Speno-Lerner, indicating he would veto it if the Legislature passed it. He said he favored the Blaine Amendment repeal route to establish parochiaid.

The governor more recently has softened his stand, saying he only objects to "the form" of Speno-Lerner and recognizes that aid in some manner is necessary at this session. He said he would still pursue Blaine repeal.

The state's bishops oppose ment of this method because of the time ban.

involved. If the Legislature should approve putting repeal to a referendum, the voters would not vote on it until November and even if repeal was voted, such aid still would be tested against the First Amendment of the U.S. Constitution.

The bishops also feel that the heat of a Blaine confrontation could hinder ecumenical relations.

The bishops and Catholic educators say the crisis is now, and aid must be secured at this session.

sultation with the public school principal."

The Catholic high schools of Monroe County have agreed to join in adopting the same policy for grades 10-12 Their policy, determined by the Association of Secondary School Principals from the eight Catholic high schools of the county, was voted Monday and sent to Father Brent for announcement.

Last Spring, after the Rochester School Board decided not to implement the Goldberg Plan, following public controversy which had prompted the Bishop's ban on transfers—the diocesan school office did authorize transfers, "with vigilance against abuses" in consultation with Superintendent Herman Goldberg and the diocesan Office of Human Development concerned with inner-city issues.

Intended reorganization of some 15,000 pupils into separate junior and senior high schools in September triggered restatement of the Bishop's original ban.
