

"The Penal Law regarding abortion which was amended in 1970 has been open to much question, criticism on the part of many New York State residents.

"First of all the Penal Law which allows legal right for abortion up to 24 weeks of gestation contradicts the State Public Health Law. The P. H. Law requires reporting as a 'fetal death', any abortional act resulting in a dead fetus regardless of the length of gestation. Where the infant is born alive, according to the P. H. Law, a birth certificate is required and in case the infant dies, a regular death certificate is required.

"Secondly, no provision has been made to care for 'legally' aborted fetuses who show definite signs of life following the abortion procedure. Consequently these 'non-vlable' infants struggle helplessly for the life to which all men have a right! State law allows the perversion of health care because the law of the State says it is right. So the infant is left to die.

"In the first instance, logic would dictate that penal law should be created TO ASSIST THE PUBLIC HEALTH LAW. New York State has allowed non-health related legislators to dictate a law which definitely has health implications . . . and this with little or no scientific evidence as to its validity. Fublic opinion is hardly a valid criteria for evaluating public health.

The Legislature did not get around to acting on the proposed changes in the abortion law. The Fight for Death people seem pleased. Statistics for the first six months of the law are: 478 unborn children destroyed daily with the blessing of the law. This is a ghoulish pleasure.

'Housing Week' Hit As Political Gimmickry

Housing Week, proclaimed by Rochester Mayor Stephen May for last week, met with stiff criticism from Father. John Hempel of the diocesan Office of Human Development, who called the idea "political gimmickry." Father Hempel supported FIGHT, a local community action agency directed by Rev. Mr. Raymond Scott, in its refusal to participate.

Father Hempel noted that Housing Week was supposed to be "informational." "We've known about this need for housing for years," he said. "The real question is, what is the political structure doing about it?"

Father Hempel conceded that the Rochester city government was making a "real effort—the problem is the towns and suburbs," which, according to him, use zoning to prevent the creation of a mixture of low and moderate income housing with property already developed.

If this continues, he warned, the next generation, which we


hope will solve some of these problems of race and poverty, will grow up isolated. We are sowing the seeds of war and discord right in our own neighborhoods, not abroad."

Father Hempel said that there is some question about what the Republican Party, "which controls the national, state and local governments, is, doing with all this power it is supposed to have."

"In the second instance, medical, nursing, and para-medical persons are forced to stand by and ignore a helpless living infant; and fail to render the helping and healing assistance to which they have dedicated their lives.

"Regardless of my religious tenets, there are sufficient contradictions in medicine and logic to place the entire law in a state of question. As a nurse, I have dedicated myself to the promotion of health and the care of the vsick, the helpless and the unfortunate, as have the majority of nurses in New York. Should we be asked to support such violations of our promises?

'I would recommend the following;

"1. Reinstate the Penal Law, Subdivision Three of section 125.05 in relation to justifiable abortion.

"2. Should No. 1 fail: a) insert a conscience clause in the present liberalized law giving all medical, nursing and paramedical persons the option to refuse to participate in any part of an abortion procedure; b) urge that all medical and nursing procedures be initiated and followed through to pre-
