There are three reasons why Catholics don't participate in Section 5 public school tournaments according to Father Daniel Brent, Rochester Catholic Schools superintendent, in an article by Tom O'Neill in "The Crest," student newspaper at Cardinal Mooney High

"First they (Section 5) have a fear that our recruiting policies would put them at a disadvantage; second, there is a feeling that our participation in Section 5 would limit their chances of being involved; and third, they don't want to change."

Father Brent added. "The issue is dead for the moment but we haven't lost interest in the idea.'


