Judge Reserves Decision On Jury System Challenge

The constitutionality of the jury selection system in Monroe County was challenged in county court last week. Judge Hyman T. Maas reserved decision on a request for a hearing until further sworn allegations are submitted to him.

The legal challenge was brought by Arthur Turco, attorney, in behalf of a client who is charged with second degree assault.

Research coordinated by the James D. Wilson Legal Defense Committee indicates, Turco claimed, that the source of names for potential jurors, the process of selection and the results of the system all lead to significant and systematic disparities in the makeup of grand juries, as compared with the general population of Monroe County. By law, juries must represent a fair sampling of the population.

The findings are based in part on a poll by the Church Women United of the 276 persons who served last year on the county's grand juries.

However, Raymond E. Cornelius, assistant district attorney, asked the court to deny a motion for a hearing on the legality of the jury selection saying: "The most the purported survey shows is a mathematical disparity, and that is not intentional discrimination."

Cornelius also said that Turco's motion papers do not contain sworn allegations as required by law.

Maas stated that "a substantial constitutional question is involved here," and gave Turco five days in which to submit affidavits, and Cornelius five after that to respond.

According to Turco's memorandum, almost half of all 1971 grand jurors participated in the survey that showed:

- A disparity between ages of grand jurors and ages of the county population as a whole. The average age of grand jurors was approximately 50 years, while 21-29 year olds make up more than 24 percent of the county population and are the largest group.

- Only 9.4 per cent of the 1971 grand jurors were 25-29, and there were none between 21 and 24, though this group represents almost 12 per cent of the county's population.

- Women constitute 52.6 per cent of the county population, but only about 19 per cent of the jurors were women.

- Although 6.6 per cent of the county's population is non-white, only 4.2 per cent of this group were grand jurors.

- The pool of 30,000 people eligible for grand jury service includes many who were admitted in the presence of a property-ownership requirement which has been declared unconstitu-

tional, and home-owners constituted 86.6 per cent of the grand jurors surveyed.

- More than 350,000 people in Monroe County are never called to either grand or petit jury service, but 71.4 per cent of the 1971 grand jurors in this research had previously served on one or more juries.

- Only 13 grand jurors last year were residents of inner city wards of Rochester, while outer city wards had 132 grand jurors. Inner city people make up 24 per cent of the entire Rochester population, but less than 9 percent of Rochester grand jurors in 1971 came from these wards.

Turco points out that Wilson, his client, is a member of five of the six classes of persons under-represented on juries. He is asking County Court to dismiss charges against his client on grounds that the grand jury that indicted him was chosen in an unconstitutional manner; and also for further investigation of these jury selection practices.

Wilson was indicted by last November's grand jury on charges of second-degree assault and obstructing governmental administration in a disturbance Sept. 30 at Benjamin Franklin High School. He pleaded innocent and is free in \$1,000 bail, pending trial.

Wilson, who was at the school as a representative of Action for a Better Community, Inc., was accused of punching Police Officer Jerome Konrad as the policeman was attempting to arrest a student.

Earlier last September, Wilson was paroled from Attica Correctional Facility after serving nine years of a 10-to-20 year term for a fatal stabbing in a barroom quarrel.
