Pentecostals See 'Stumbling Block'

Notre Dame, Ind. (RNS) -Traditional Protestant Pentecostals have been surprised by the growth and depth of the Pentecostal movement in the Roman Catholic Church, but they see a stumbling block:

They are "scandalized" that Catholic neo-Pentecostals can smoke and drink and still have the Baptism of the Holy Spirit, a traditional Pentecostal reported at a seminar here during International Conference the Charismatic Renewal in the Catholic Church.

Vinson Synan, a professor at Emmanuel College, Franklin Springs, Ga., and author of a history, "The Pentecostal Holiness Movement," said the Pentecostal Holiness churches are now having to make an "agonizing reappraisal" as to just what makes a Pentecostal.

He said he found himself "rejoicing at the growth of the Catholic charismatic movement '

"The spirit of God told me it was real," Mr. Synan said. He said most Protestant Pentecostals would be surprised to know that the Catholic Church was "adaptable enough" to include Pentecostalism in its theology

He said the 600 million-member Roman Catholic Church could become the greatest vehicle for evangelization of the world if its charismatic movement

Synan warned that the charismatic movement must not neglect personal sanctity and "lest speaking in tonholiness gues become sounding brass and tinkling cymbal.'
