

Slaying Victim Mourned By St. Patrick's School

Elmira — Timothy Schmidt, an eighth grade student at St. Patrick's Junior High School here, won't be experiencing the fun of joining activities with his classmates, won't be worrying about his upcoming examinations and won't be graduating with his class in June. Timothy Schmidt was found slain Wednesday afternoon.

The 14-year-old student's body was found in a shallow grave some 75 to 100 yards from the Chemung River. The eighth grader had been missing from his home since 4:30 p.m. last Monday.

School officials were notified Tuesday morning that the boy still had not returned home.

The horrible truth surfaced Wednesday when police, who were searching for the youngster, uncovered the grave. Less than 12 hours after the boy was found, police charged another Elmira youth with Timothy's murder.

David Goodwin, 17, has been charged in the death.

He is being held without bail in the Chemung County Jail while waiting grand jury action.

1st Communion Classes Set For Parents

For Timothy his life ended, according to the county medical examiner, some time before 5 p.m. Tuesday.

The dead youth was described by his principal as an average student who had a "very nice personality." Sister Claire Fran-

ces, the principal, said, "His classmates liked him and he was friendly with the teachers."

In respect to Timothy, a special Mass was celebrated Thursday. The entire student body and faculty turned out for the service in St. Patrick's Church.

Saturday many of his classmates and teachers were at St. Patrick's as the Mass of the Resurrection was celebrated for Timothy.

He was buried later that day at St. Peter and Paul's Cemetery in Elmira.

For the rest of the students at St. Patrick's Timothy might be gone from their sight, but he will always remain a member of their class. Timothy's twin brother, Tommy, is also a member of the eighth grade class at St. Patrick's.

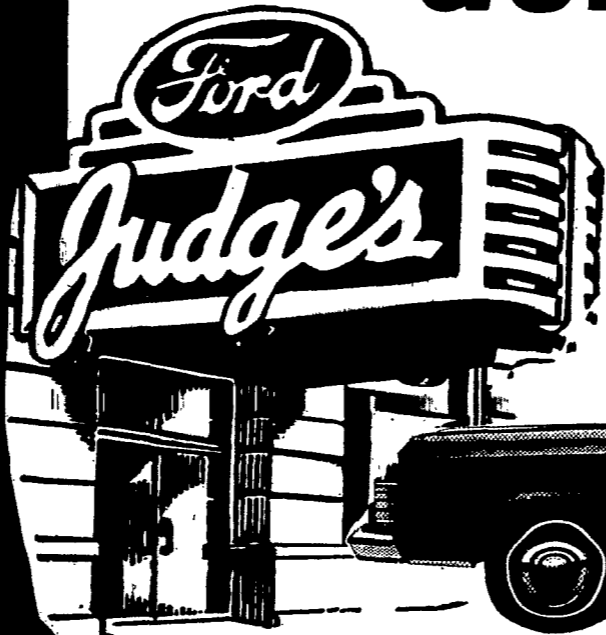

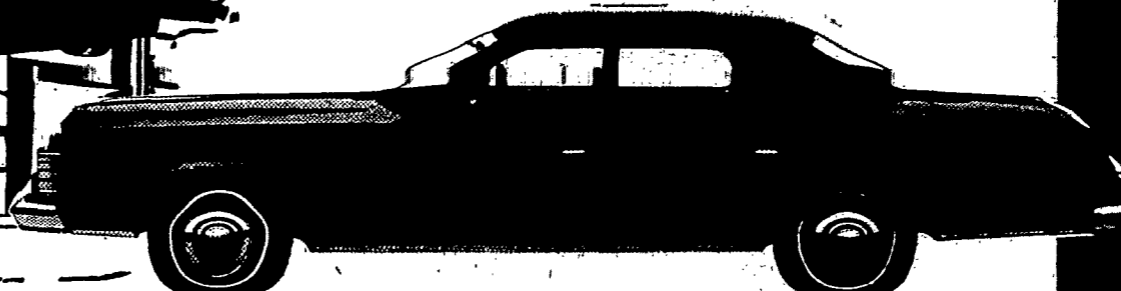
