SBA Deadline Changed

Washington — Thomas S. Kleppe, administrator of the U.S. Small Business Administration today extended the deadline for accepting loan applications from Hurricane Agnes disaster victims in New York and Pennsylvania to Jan. 15, 1973. The deadline previously was set for Oct. 31 of this year.

"The continuing volume of applications for SBA disaster loans in New York and Pennsylvania and the urban renewal work being conducted there by the Department of Housing and Urban Development has convinced us of the need to give disaster victims in these two

Seminary Supports

Boycott

The United Farm Workers Organizing Committee picked up additional support this past week from St. Bernard's Semi-nary for its "Boycott Lettuce" campaign.

In July, the Social Development Committee of the U.S. Catholic Conference in Washington, an agency of the country's Catholic bishops, announced its support of the nationwide boycott of iceberg lettuce called by Caesar Chavez's

The committee stated that a "fundamental issue of social justice" is at stake in the farmworkers' attempt to negotiate with lettuce growers in California and Arizona. The Farm Worker's Union wants its sup-porters to boycott iceberg lettuce unless it bears the label with the union's black Aztec eagle on the individual wrap-

The Farm Workers' Union, which is headed by Caesar Chavez, claims to represent a majority of farmworkers, and it has tried for more than two years to negotiate union contracts with big California lettuce growers

The resolution passed by the Student Council and Faculty of St. Bernard's Seminary stated: "Be it resolved that the community of St. Bernard's Seminary, acting out of our Christian committment to our fellow human beings, and prompted by the moral-law of charity in helping migrant farm workers attain dignity for themselves, self- determination for their union, and justice for themselves and their families, shall hereby refrain from buying non-union lettuce".

This action was a formality and statement of conscience, since St. Bernard's stopped buying non-union lettuce in mid-September in sympathy with the workers, according to a spokesman for the group.

states additional time to file applications," Kleppe said.

He said the Department of Housing and Urban Development has indicated it will determine by Dec. 15 those areas that qualify for urban renewal assistance from HUD and which areas can be rehabilitated. Structures in those areas marked for urban renewal will be demolished and owners assisted by HUD. Property owners and businessmen in areas to be rehabilitated will be eligible to apply to SBA for assistance.

'We feel that an additional

30 days beyond the time HUD completes its urban renewal determination will give those whose property can be rehabilitated the time they need to apply for SBA assistance," Kleppe said.

Kleppe said SBA has received 96,400 applications totaling \$881 million from disaster victims in the two states, and already has approved 87,000 applications for \$564 million. This is the major portion of the 100,000 applications for \$642 million approved by SBA in the sevenstate area devastated by Hurricand Agnes last June 23.
