Bishops May Mediate Farm Union Talks

Burlingame, Calif. [RNS] — Peace talks between high officials of the United Farm Workers Union and the Teamsters, broken off abruptly Aug. 10 when UFWU leader Cesar Chavez walked out, are expected to resume within two weeks, it was reported here.

At the same time, it was announced in Hartford, Conn., that a special U.S. Catholic bishops committee was making itself available to mediate the UFWU-Teamsters dispute.
