# Lack of Interest?

A Rochester couple, trying to learn the status of the Hogan Amendment to secure the rights of the unborn, wrote to all nine members of a House Judiciary subcommittee where the bill rests now.

Rep. Charles E. Wiggins, a Californian, answered them that the judiciary committee has relegated the abortion bill to low priority because of lack of interest.

"You should be advised," he wrote, "that as of Sept. 2, 21 congressmen have sponsored Hogan's resolution or some variant thereof. Twenty-five congressmen have sponsored constitutional amendments which are directly the opposite of the Hogan resolution.

"You may also wish to know that to date I have received approximately 300 letters from around the country concerning the Right to Life amendment, 60 per cent of which have been in opposition to the amendment."

Unhappy news indeed.

We all must revitalize our efforts for the unborn. The area Right to Life Committee urges that everyone interested in reversing the Supreme Court decision on abortion write to members of the judiciary subcommittee and urge high priority for the Human Life Amendment, HJ Res. 261.

Write now. The House is close to adjournment.

## Letter Sent **To Senators** Editor:

Your readers will be interested in the following letter sent to the 100 U.S. senators and 435 U.S. representatives in regard to the Human Life Amendment.

Honorable sir:

The Committee of Ten Million has in its possession more than two million signatures on a petition to the Congress for the Human Life Amendment.

These signatures have been received since Easter. They are already broken down hv congressional district. A Fall program has been launched to secure eight million more signatures.

The thousands of petition gatherers are being organized by congressional district so, as to become politically effective insofar as the Human Life Amendment is concerned. The indications are that 1974 will see a "one-issue" campaign.

You will be interested in the results of our grass-roots, nationwide, preference surveys:

1. The "States Right" type of amendment (Whitehurst proposal) is totally unacceptable. It is immoral.

2. The Buckley Amendment, in spite of the public relations effort of its backers, has only 10% of its backers, has only 10% support in the constituencies. This is because of basic defects in the amendment wording.

As the world grows smaller, it becomes increasingly difficult to justify war. It becomes ever so much more important to avoid it.

Admitted, one war may vary from another in circumstances. The constants, however, are disturbing – destruction of youth, waste of material and money, and the increasingly evident fact that wars seldom solve the problems that cause them.
