Mrs. D. is appreciative of any help given her. Her family has been able to celebrate Christmas in the past only because of the generosity of people who share their love in a concrete way through the Christmas program. Catholic Family Center.

7 Mrs. J. is a widow who supports herself through day work. However, she is now up in years and is not able to work as much as she had in the past. She manages to support herself but on holidays she brings her son home. He is in an institution for the mentally retarded. ## Bishops Back Boycott

Continued from Page 1 Bishops (NCCB), also urged growers and the Teamsters Union to "accede" to the UFW demand for free elections without delay.

Although the UFW has enjoyed widespread support in the Catholic Church, as well as among many other religious groups, this is the first time that the bishops' conference has formally endorsed a UFW boycott.

Auxiliary Bishop Joseph Donnelly of Hartford Conn. chairman of the bishops ad hoc committee on farm labor who made the proposals, told the bishops that the "very existence of the UFW is at stake in this struggle." •

After tracing the three-year history of the dispute between the Teamsters and the UFW over jurisdictional rights among California farm workers, the prelate said his committee "is convinced that the cause represented by Cesar Chavez and the UFW is a just cause. We are persuaded that the UFW represents the best interests of the nation's agricultural workers and that it deserves our wholehearted support.

Wholehearted support is what the committee's proposals received. Every speaker to the motions supported the recommendations of Bishop Donnelly's committee and the proposals were adopted without dissent. A unanimous voice vote carried both motions.



#### Holyday Obligation

The following is the text of a memorandum issued by the Pastoral Center on Mass obligations.

Several priests have asked whether the faithful who make use of the Saturday Mass privilege in fulfilling their Sunday obligation will also at the same time fulfill the obligation of attendance at Mass on the holyday, Dec. 8, which this year falls on a Saturday.

The Sacred Congregation for Clergy replied in the NEGATIVE to a similar inquiry in a letter dated September 16, 1969 [Prot. N. 125647/1]. In other words, the Saturday privilege which is given to facilitate the fulfillment of the Sunday obligation in no way derogates from the separate obligation of the preceding day. The faithful may fulfill their obligation for Saturday, Dec. 8 by assisting at Mass on Friday afternoon or evening. The same will hold true for all similar circumstances.

# Sisters Discuss Clergy Conferences

January Clergy Conferences were discussed at the monthly Diocesan Sisters Council (DSC) meeting Nov. 17 in Elmira.

The council's New and Pastoral Ministries Committee arranged the program for the conferences which will consist of panels of priests and sisters.

Topics will include finances, ministry and the community.

The conference for those priests in the Rochester area will be Ian. 15 at Becket Hall and was arranged by Father John O'Connor and Sister Elizabeth Anne LeValley, SSJ.

The Jan. 16 clergy conference for those in the Southern Tier also is being directed by Father O'Connor and Sister Edwina Butler, RSM.

Since it was the first time the DSC had met in the Southern Tier, other business discussed included the school consolidation and inter-congregational staffs in the Elmira area.

School consolidation became a reality in 1971, but because of the 1972 flood this is the first year it is operating under normal circumstances.

The Sisters chose delegates to attend a Dec. 5 meeting at St. Stephen's in Geneva on the rewriting of the Diocesan Fund Development Office Proposal.

They are Sister Rosalma Hayes, SSJ, Sister Scholastica Caufield, RSM, and Sister Veronica Casey, RSM. All three were on the council's ad hoc committee set up to study the proposal when it was first presented in September.

A Spring Workshop planned by the DSC will be held for diocesan priests and religious on April 28 from 1 to 5 p.m. at Nazareth Academy. The speaker will be Sister Suzanne Bruckle RSM, from Providence, R.I. She will speak on The Committed Minister: Relationship In and Around the Community.
