Dear Faithful Reader,

Your letter came in May but I have hesitated to answer it because it is a question of five words but an answer of volumes.

If I were to answer "Yes" my
answer would be so imcomplete as to be false. If I were to answer "No," not only would I be flooded with violent protest, but I would be unfair in seeming to write it off as having no importance. Let me quote a bit from Father Eugene Kennedy's book, "What A Modern Catholic Believes About

"There is no doubt that masturbation has been considered a sin almost throughout the history of the Catholic Church. It has been considered a sin, or at least a shameful action, by many men outside the Church as well. I believe that this tradition of the Church is rooted in a concern for man and for the proper integration of sex into his personality. I do, however, believe that, while this concern is laudable, it has been based on an underdeveloped appreciation of man's sexuality and the overall patterns of human growth. I think we understand man better now and we also have some new opinions about sin. It is not all quite as simple as it once was."

Elsewhere Father Kennedy says, "Theologians and others have felt that once you take away the label of sin, you have excused man of any responsibility at all Declaring something as not being sinful seems always to be interpreted as issuing a license for all kinds of wrongdoing that we excuse on the basis of psychological theory. This is the outlook which we feel must in some way or another be held on some moral standards or everything will collapse. If masturbation is indifferent, if we do not keep some kind of check on it, then serious consequences may arise. The problem is that we do not have to dismiss mastur-bation as if it were of no significance when we put aside the categories of sin. Mastur-bation is important and it is not something we advocate, as some presumably liberated social scientists do, as a 'healthy outlet' for sexual tension. This latter attitude betrays a lack of comprehension of the meaning of masturbatory activities in human growth and development."

conclusions: masturbation cannot be simplistically described as a sexual mortal sin; 2. It can be an important symptom of negative emotions the individual is not coping with (fears, depressions, boredom, insecurity) in which case it is these emotions which should be dealt with more rationally; 3. it could be a sign of rationally; 3. It could be a sign of inability or junwillingness to relate to other human beings as we should, hence an act of selfishness betraying a selfish attitude; 4. often it produces terrible guilt feelings which only make the situation worse, the person more helpless and destroy the sense of self-worth and make the person unrealistically feel like a moral degenerate. Then you have a vicious circle.

Having now left myself open to the charges of being unclear and evasive, I highly recommend seeking the dounsel of a priest who has had some training in psychological counseling to sort out the individual problems which are there. Your question — five words! My answer — about four hundred! Please talk with a

State Death Penalty Struck Down

Washington, D.C. [RNS] — New York State's narrowly defined death penalty was struck down here by the U.S. Supreme Court in a brief announcement without comment.

The high court refused to hear an appeal from the State's Court of Appeals which declared the capital punishment law unconstitutional last June.

As amended in 1965 and 1971. the statute allowed the death penalty in only three types of convictions: killing a police officer in the performance of his duties; murder by a life-termer in a state prison, and the slaying of a prison guard or other jail em-

The New York Court of Appeals, reflecting the U.S. Supreme

Court's ruling of 1972, said the law violated the Eighth Amendment prohibition on "cruel and unusual punishment."

According to the state court, only a mandatory death penalty for specific crimes would meet the high court's objections to the arbitrary manner capital punishment has been administered in

Attorney General Louis J. Lefkowitz of New York and Oneida County District Attorney Richard D. Enders appealed the state court ruling in the case of Martin J. Fitzpatrick, convicted of killing two policemen in September, 1969.

Five persons were on New York's death row when the Supreme Court refused to hear the appeal. Officials expected that the death sentences would be commuted to life imprisonment.

In addition to limiting the types of cases in which capital punishment could apply, the New York law also required a separate "penalty trial" and unanimous jury recommendation of death.

Since the Supreme Court ruling last year, there, has been considerable confusion on what if any death penalty laws can be constitutionally enacted by the

Some 20 states have passed new laws, most of them attempting to overcome arbitrary imposition of capital punishment by requiring death for certain stipulated crimes.
