## State Court Upholds Law On Obscenity


Albany [RNS] - The New York State Court of Appeals has ruled by a margin of four to three that the state law against obscenity and pornography "more than complies", with standards laid down by the U.S. Supreme Court. In the majority opinion, Associate Judge Domenick L. Gabrielli noted that the Supreme Court called for the use of community standards. And he specified that "the community standard to be applied is a state

standard." Dissenting, Associate Judge Sol-Wachtler asked, "Is a man to be convicted of displaying obscene material even though he suc-cessfully gauged the standards of New York City where the material was displayed, because our court ultimately decided that the more stringent standards of Elmira were more reflective of statewide standards?"

The court's decision upheld the nisdeameanor convictions of Jim Buckley as publisher and Al Coldstein as editor of the tabloid newspaper Screw. They had been convicted by a three-judge. New York Criminal Court-panel on six obscenity charges and sentenced on each count to a \$500 fine or a 30-day jail sentence. The con-viction had been upheld by the Appellate Division, First-Department, of the State Supreme Court, (In New York, the Supreme Court is not the top court.)

The Court of Appeals decision also upheld the conviction of

# Convent Remodeled For Health Center


Remodeling began last week that will turn a former Westside. convent into a modern, comprehensive health center.

The new center at 30 Millbank. St. is one of three in the Westside Health'Services of the Rochester Health Network

A \$154,000 contract for complete internal renovation of the attractive stone building was signed last week. The 40-room, three-story structure was pur-chased last year from St. Monica's Parish.

The Westside Health Services centers are staffed by specialists in family medicine, which means that a single physician supervises primary care to all family members; including adults, children, and babies. The family physician works with a team that includes nurses and nurse-practitioners

Although x-ray services will initially be performed at St Mary's Hospital, the renovated building will include leaded walls and necessary electric wiring to accommodate x-ray equipment in the future.


