

10 Deacons To Be Ordained To Priesthood

Ten young men who went out from St. Bernard's last Spring as deacon interns will be ordained to the priesthood in separate ceremonies during the next three months. They completed their theological studies in May, 1973.

Each will be ordained in the parish where he has been living and working in this first year of his intern commitment. He will continue for three more years to develop his pastoral skills under the guidance of a parish priest who has had special training as a supervisor. The Deacon Intern Program is directed by Father Edward Steinkirchner, pastor of Holy Ghost.

Bishop Joseph L. Hogan will ordain the first seven of the candidates on the list that follows. Auxiliary Bishop John E. McCafferty will ordain the next two, and Auxiliary Bishop Dennis W. Hickey, the remaining one.

Dr. Jefferson To Be Keynoter For 'Life' Dinner

The keynote speaker for the March 23 Right-to-Life annual dinner will be Dr. Mildred Jefferson, an outspoken, nationally-known pro-life advocate. An implacable foe of abortion, she links the abortion trend to other prevalent anti-life practices, and analyzes this mentality in its social, economic, legal, medical, and ethical framework.

She has said that "indulgence of the annihilationist's selfish creed of destruction of the unplanned, imperfect, underprivileged and inconvenient ones among us is the way to extinction."

In an address last June, she said:

"The majority opinion of the Supreme Court decision on abortion handed down on Jan. 22, 1973 condones, and thereby promotes, the willful destruction of millions of unborn Americans. By denying the state the right to intervene in the private decision of a woman and a doctor to end the life of the unborn child, the Supreme Court created a new class of super-citizens with the private right to kill. The unborn child, declared non-person, becomes non-citizen, subject to death on discovery. If a woman and her doctor are to retain the

right of the private death contract, who will have it next?"

A graduate of Harvard Medical School, Dr. Jefferson is a surgeon and an assistant professor of surgery at the Boston University School of Medicine. She is a diplomat of the American Board of Surgery (a diplomat is a physician certified as a specialist by a board of examiners). She is a member of local, state, and national medical societies, and she is on the boards of directors of state and national pro-life organizations.

Dr. Jefferson is one of the most articulate spokeswomen of our day in this vital socio-moral field related to the dignity of human life. She presents a message that is literally vital to future generations.

Tickets for the event are \$15 per person. Those contributing \$25 or \$50 will be listed as sponsors or patrons. The program also will include a performance by folk singer Barbara Breuer-Sipple and a short film on the rights of the retarded. Tom Decker of WROC-TV will be master-of-ceremonies.
