The Pre-Cana Happening

Do yoù remember your Pre-Cana instructions? We dol We sat through four Sunday sessions listening to dedicated people talking to us but not with us, about various aspects of married life. Not having participated in these instructions, we could very easily have left them behind when we left. For us Pre-Cana did not provide any new insights into our future married life.

Today in our society marriage itself is often challenged. Our engaged couples really do not know what to expect in this new venture. They have hopes and dreams of what life will be like when they are married, but very often reality is far from their ideals.

To meet today's needs, there is

a new happening in Pre-Cana. There is a need for engaged couples to express their own ideas and expectations for the future together — to bring reality to the present. This is what the new Pre-Cana is all about.

It is a discussion type of program in which 25 engaged couples inter-act with five married couples a doctor and a prest. The married couples give short presentations on various aspects of married life communication, outside influences, finance, sex, spirituality, growth and reality in marriage, etc. After each presentation, there are small group discussions in which the engaged couples relate to the married couples' experiences and express their own ideas. We have found an overwhelmingly favorable response to this type of program. Engaged couples have told us that they have never talked so deeply as during the week when the four Pre-Cana sessions were held. At the same time, the engaged couples are gaining insights into what marriage can really be while the participating married couples are experiencing an enrichment" in their own marriage. For us, this has generated a twofold satisfaction. There is a great need for interested married couples to participate in forming new Pre-Cana teams. The diocese hopes to convert Pre-Cana instructions to this new group dynamic form. However, more married couples are needed for this transition.
