# Xerox Withdraws Controversial Booklet

The Xerox Corp. has agreed to withdraw from distribution a booklet entitled "Popula-tion Control" after the Catholic League for Religious and Civil Rights threatened a suit alleging anti-Catholic statements in the booklet.

Stuart Hubbell, a Traverse City, Mich., lawyer who is executive director of the league, said he would recommend to the board of directors that pending legal action be stopped in view of the Xerox decision.

According to Religious News Service, Hubbell said he received a letter from the corporation stating that all copies of the booklet would be removed from the market and that the booklet would not be reprinted or copied.

In announcing the planned legal action in June, Hubbell had charged that statements in the booklet constituted "a deliberate and malicious libel" on Catholics, particularly in a chapter entitled "The Pope's View on Birth Control.

The booklet was being used in high schools in Birmingham, Mich.; St. Louis; Lincoln, Neb.; and Dade County, Florida.

It was prepared by Xerox Education Publications, a subsidiary of Xerox located in Middletown, Conn. It was adapted from the Harvard Social Studies Project under the direction of Donald W. Oliver, Harvard University professor of education, and Fred W. Newmann, University of Wisconsin professor of curriculum and instruction.

> The chapter the Catholic League found objectionable includes some quotes excerpted from Pope Paul's 1968. encylical, Humane Vitae. The chapter then includes the complete statement purportedly signed by 3,000 scientists shortly after the encyclical was issued.
