'You can't," answered the banker. "You've got to keep jumping."

Zacchaeus was a wealthy man. He had climbed the ladder of worldly success. In a rich town he must have been among the ten richest, for he was "the chief tax collector." That was like having bought a franchise from the United States Government giving one the right to collect all the income taxes in Rochester. It was a bonanza! A guy could get to the top in such a profession only if he knew how to make the best of opportunity. Zacchaeus was an opportunist. He knew enough to open the door whenevery op-portunity knocked.

Apparently, however, money wasn't everything. Zacchaeus' job had gotten him thoroughly detested by the people. Every "good" Jew literally "hated his guts." Ostracized by his countrymen, he must have been lonely. Burdened with the guilt of a dishonest profession (for he was a Jew, knowing the true God), he must have had no peace of heart. Guilt, loneliness tormented him. Then came an opportunity to rid himself of this inner torment. And Zacchaeus, used to seizing the opportune moment, jumped at this one. Jesus was passing through Jericho. Zacchaeus certainly had to know all about Jesus. Businessmen know current

Another trait about this. Zacchaeus that made for his success was his determination. He had to be a persistent man. He revealed his persistency on this occasion. There is a song about Zaechaeus written by the Medical Mission Sisters. One line in it goes like this: "The Hebrews, they were tall, but Zacchaeus, he was small, yet the Lord loved Zacchaeus, better than them all." Zacchaeus was small. Iesus was passing by. Two things militated against Zacchaeus' seeing Jesus h his smallness and the throng. Instead of giving up, Zacchaeus ran on ahead to search for a better vantage point. He found a sycamore tree. Climbing its lowhanging branches, , Zacchaeus had the best view of all. He always seemed to know how to come out on top!

How did Jesus react? " He looked up and said, 'Zacchaeus, hurry down. I mean to stay at your house today." Jesus addressed Zacchaeus and meant to heal them. "Hurry down," He said, " I mean to stay at your house today." Again Zacchaeus seized the opportunity. He descended quickly welcomed him with delight."

Here we have re-enacted in life two of the parables of Jesus. First, the Parable Prodigal Son. The coming of Christ is always: unexpected. His stay is brief. He is passing by and may never come this way agian. Lost opportunities can never be found again. Long ago, Juvenal wrote: Carpe diem"—"Seize today." Now is the opportune moment to find Christ. Never will there be a more opportune one than now! Wait 10,000 years, your sins will not be fewer; nor will God's mercy be greater. Seize, therefore, the coming holy year. When better to be renewed and reconciled than now.
