Censorship Decree Issued by Pontiff

Vatican City [RNS] — Pope Paul has issued a decree reaffirming the Roman Catholic Church's pre-publication censorship, but in broader terms, with effectiveness dependent more on an individual's sense of duty rather than on formal sanctions.

The decree, issued on the Pope's orders by the Vatican Congregation for the Doctrine of the Faith, "seriously warned" lay persons against contributing writings to newspapers or magazines hostile to Catholic religion or morals, except for "a just and reasonable cause."

The three-page document also strongly urged priests and religious men and women to seek the permission of their bishops or superior if they wanted to publish books on religious or moral questions.

In the past, priests and religious were required to seek approval before publishing any book, including those on non-religious subjects.

The new decree restated the directive that previous ec-

clesiastical approval is manadatory for catechisms, translations of the Bible, altar and prayer books. Art "imprimatur" ("let it be printed") must appear on the front page of all churchapproved publications.

The decree said, further, that in the future no books about religion and morals can be used as textbooks, in Catholic schools or displayed or sold in Catholic churches unless they carry the imprimatur.

2 BISHOPS NAMED

Washington, D.C. [RNS] — Pope Paul has named new bishops to the dioceses of Raleigh, N.C., and Nashville, Tenn.

Auxiliary Bishop F. Joseph Gossman of Baltimore, Md., 45, was named Bishop of Raleigh to succeed Bishop Vincent S. Waters, who died last December.

Msgr. James D. Niedergeses, 58, pastor of Saints Peter and Paul parish, Chattanooga, Tenn, was named Bishop of Nashville. He succeeds Bishop Joseph A. Durick, 60, who had asked to be relieved of administrative duties upon completion of 20 years as bishop
