Her Race for President A Life and Death Matter

Bellmore, N.Y. — Democrats at their national convention next year may have to grapple seriously with the question of abortion and the long-stalled Human Life Amendment to the constitution. That is if Ellen McCormack has her way.

Mrs. McCormack has thrown her hat into the ring for the Democratic presidential nomination, will enter primaries across the nation, and hopes to raise enough money to air pro-life television, advertisements.

What happened was that a group called the Pro-Life Action Committee, a political action and

fund-raising unit stationed here, selected Mrs. McCormack, a columnist for Women for the Unborn, to mount a campaign for president.

Mrs. McCormack recently noted that Pro-Life's "primary purpose" at its founding "was to launch a TV advertising campaign on behalf of the unborn child. Since CBS, NBC and ABC refuse to allow educational TV commercials on 'controversial' issues, the only way to avoid TV censorship of the Right to Life advertisements was to have them sponsored by a political can-

She says that the Democrats control Congress and the Congress has refused to act on a Human Life Amendment," because pro-abortion organizations, such as the Women's Political Caucus exert a tremendous political influence within the Democratic party. While there are millions of prolife Democrats throughout the country, they have not yet been organized within the Democratic party in an effective manner.



Thirty-one church related people, including clergy, nuns and laymen, have charged that the new California state law designed to help farm workers gain union representation is being "subverted." are being intimidated and abused and California is failing to act in their behalf, the group claims . . . Helen Hayes, veteran actress of stage, screen and television has received an honorary doctor of humane letters degree from St. Peter's College of Jersey City. The award was given during a Mass at her home parish, St. Ann's in Nyack, N.Y. Bishop Floyd L. Begin of Oakland has established an Office of Criminal Justice in his chancery. "As followers of Christ, we should be actively concerned about criminals, prisons and the whole system of criminal justice. The vindictive attitude of 'lock them up and throw the key away' is not consistent with human dignity," he said.

Pope Paul, during rites canonizing Spanish Dominican Juan Macias, denounced as "dastardly" the execution of Basque terrorists in Spain. He earlier condemned terrorist action, yet had repeatedly appealed to the Spanish Government to grant clemency to the Basques. When they were executed, he expressed his "bitterness" and called the action "homicidal repression." The government, in turn, boycotted the canonization and has called its ambassador to the Vatican back to Spain . . . Cardinal Maurice Fetlin, former Archbishop of Parish and a champion of the controversial priest-worker movement of the 1950s; has died at the age of 92. The Cardinal also was deeply involved in the Pax Christi international movement for peace and supported Algerian independence from France . . . He also was among the churchmen who appealed in vain to President Dwight Eisenhower to spare the lives of Julius and Ethel Rosenberg.
