How to Verify A **Service Representative** Is From RG&E

RG&E personnel visit area residents for many reasons concerning gas and electric service. In some cases customers are expecting them; in other cases they are not. There are several ways you can verify that a service representative is from RG&E.

RG&E is aware that customers may be apprehensive. For this reason all RG&E personnel carry identification cards. The card contains a picture of the employee with his or her name and signature, and RG&E's full corporate name, Rochester Gas and Electric Corporation.

If the representative is at a solid door which you don't want to open,ask him to go around to a window or fo another door which has a window. This way you will be able to see the identification card. You may want to take a further precaution. During the day you can ask the employee for the name of his or her department at RC&E and its extension number. Then you can call the department to verify that the representative is scheduled to visit your residence. After 5:00 PM it is still possible to get a verification because RG&E maintains 24-hour telephone



The Heat Pump: **Heating and Cooling System**

Information Center features the heat pump, the most efficient electric heating system in use today. The heat pump is actually a heating and cooling system which transfers heat from outdoor air into your home in winter, and from your home to the outside in summer.

October's Consumer It's hard to believe, but outside air even at sub-zero temperatures contains heat that can be removed by a heat pump and circulated throughout your home; In summer the process is reversed to remove heat from your home and vent it outdoors, just as an air conditioner does. Reversal of the system can be

An Important Notice to our Gas Customers

On February 1, 1975 RG&E's supply of natural gas was curtailed for an indefinite period of time by its supplier, Consolidated Gas Supply Corporation. Some of our customers were immediately affected because of a prior commitment to switch to an alternate fuel in the event that our supply was curtailed.

To protect the supply of gas for our remaining customers, we are denying service for new or additional load attachments of any size. Equipment which was operated prior to February 1, 1975 may be replaced if required. However, please do not connect any new or additional gas burning equipment or otherwise increase your consumption. Unfortunately the penalty for violation of the curtailment restrictions could be severe.

On the other hand, if your gas account remains inactive for twelve months or more, you'll have to forfeit entitlement to gas service during the curtailment. So be sure to discuss your plans with us before altering your present operations.

Air Conditioner Care Can Save **Energy In Cold Weather**

The Major Appliance Consumer Action Panel (MACAP - a panel that analyzes consumer comments and complaints dealing with major appliances) has found that removing or covering "window" air con-ditioners will contribute to energy conservation.

By removing the unit from the window, the flow of cold outdoor air through and around the unit is blocked off.

For continued efficient use, the window air conditioner should be stored in a clean, dry place. This eliminates dirt, moisture, and rust accumulation. Be sure the unit itself is clean and dry before it is put away. If you cannot remove your air conditioner from the window, cover it with a heavy duty cover of the same size and shape to protect the unit and to decrease leakage of heat from room. It is always a good idea to clean the condenser part of the unit with the hose attachment of your vacuum cleaner at the end of the cooling season as well as the beginning.

The heat pump also uses supplementary electric resistance heating coils during the heating cycle for two reasons. First, they supply heat when the unit is operating at temperatures below the balance point of the system, the lowest temperature at which the heat pump alone can handle the heating load. This is an outdoor temperature of approximately ム 25°F(-4°C*). However, a properly designed heat pump for our area should continue to provide part of the heating need, even at temperatures below zero. The supplementary resistance helaters provide the balance of the heat required.

Second, there is a defrost system for removing moisture which collects and freezes on the outdoor coil. To melt frost buildup, the system is reversed to a cooling cycle which heats the coil. The supplemental heat is needed at this time to counteract the cooling effect of the cycle change. In addition, the resistance heaters can be used to supply all the heat required if the refrigeration part of the system should fail.

The initial cost of installing a heat pump system in your home may be slightly more than that for individual central heating and cooling systems. However, operating savings will help to off-set the higher first cost.
