Hopefully, the voters of New York State will be informed of the following:

1. There is no discrimination against women which can be corrected by passage of ERA. Since 1963, the U.S. Congress has numerous discriminatory laws which touch every facet of a woman's existence. ERA is unnecessary.

2. The ERA would leave all issues to the courts rather than the legislature to decide. Inherent in this situation is that judicial power, the least responsive segment of government, is increased. At the same time, the power of the legislative branch of government, the most responsive to the people, is diminished.

3. There are over 200 laws now in effect in New York State which protect or benefit women. (We enclose the official listing, as published by N.Y. State Law Revision Commission for editorial consideration.) These will be invalidated by ERA.

The moral dimension of the ERA is as direct as any issue affecting justice and preservation of harmonious family life. Stable societies recognize that safeguards should be maintained around wife and mother as center of the family.
