## Editorial

### Albany Bumpers

Whether by design or because of fumbling bureaucracy, the State Assembly has managed to "defeat" a bill that would require parental consent before doctors could perform abortions on women under 18.

The Senate had already passed the measure and observers felt that the Assembly would follow suit when it came to the floor. Instead the Assembly Codes Committee aborted the bill by making changes which will require re-printing, thus delaying it long enough that it probably won't make it to the floor this session.

The Codes Committee cannot kill a bill already passed by another committee (Health, in this case) but apparently members of the Codes Committee have found a way to accomplish virtually the same thing. The scenario raises questions. First of all, Herbert J. Miller of Queens, as chairman of the Health Committee, referred the bill to Codes, which, it is said, is proper procedure because penalties are involved in the measure. Fine. But then the same Miller introduced the amendment in codes (removing penalties) which has stalled the bill.

The State Catholic Committee has urged passage of this bill as a "family support" bill, which is putting it very mildly. We urge all our readers who feel that it is proper for parents to counsel their daughters under 18 before they have abortions to write their assembly representatives at the Legislative Office Building, Albany, N.Y. 12224. The matter is urgent; the Assembly will be adjourning, probably in June.

One more point should be made in regard to this bill. News accounts unwittingly refer to "right to life pressure" as coercing assemblymen into voting for the bill. We resent the implication, whether made purposely or not, that the right to life movement is some dark, sinister force wielding improper power. Many more citizens, both in and out of official Right to Life circles, support this bill for obvious reasons. It should not be obscured by prejudiced generalizations.

### Services Needed

Kudos to Msgr. Charles Fahey, executive vice president of Catholic Charities in neighboring Syracuse, for his recent strong plea in behalf of the nation's aging. Msgr. Fahey, writing in a journal of the National Conference of Catholic Charities, called on experts in health and social services to promote recognition of the elderly's ability to begin a "new phase" of life after 65.

That people become "old" at 65 is a "legal fiction" which society uses for its own convenience rather than for the well-being of the individual, Msgr. Fahey points out.

We agree. Society has overbought the premise that "youth must be served." It has forgotten that wisdom, experience and the philosophical benefits of having lived through it all must not be discarded. Most older persons are not asking to "be served" rather they look for the opportunity to serve.

### CAP BOOK Sends Thanks

THE CAP BOOK, Inc. would like to extend our deep appreciation to the Courier-Journal for its service to the waiting children. As we conclude the feature on The Children Who Wait which has been presented weekly since August 1975, we would like to share with you some of the results.

Thirty-seven waiting children have been featured. Seven of these children have been placed in permanent adoptive homes, with another five children in the process of being placed. We are aware of several families who have begun to work with local agencies toward adoption. Positive responses from both the lay and religious communities have been received indicating their awareness of the needs of the waiting children through the series.

The Courier-Journal is to be commended highly for its genuine concern and commitment to portraying the children with much sensitivity to their particular needs. Not only has the community become aware of the children and the changing adoption scene, the children themselves, have had the opportunity to participate in helping to find homes.

Most of the children who have been listed in THE CAP BOOK are now featured in the newly created New York State Adoption Service Books. These books and other picture listings from Illinois, Massachusetts, and Indiana are available to the public at THE CAP BOOK Office. THE CAP BOOK hopes to obtain private funding to continue its service to the waiting children through a nationwide picture listing service. There remains much work to be done. It is estimated that over 100,000 children in the United States remain unnecessarily in foster care who are in dire need of adoption planning.

We look forward to the possibility of working cooperatively with the Courier-Journal again in the future, for it is only through the generous contribution of the media that the public can become acquainted with and respond to the needs of The Children Who Wait.
