The Red Mass Committee of the St. Thomas More Lawyer's Guild is making final preparations for the 31st Anniversary of the Red Mass at St. Mary's Church, 15 South St., on Friday, Sept. 24, at 12:15 p.m. The principal concelebrant will be Bishop Joseph L. Hogan. A tradition stemming from the 4th Century, the Red Mass marks the opening of the Court for the coming year and is an invocation for spiritual guidance and blessing to the legal profession, the law enforcement agencies and the judiciary. The annual Red Mass was started in the Rochester area in 1945 under Bishop James E. Kearney. The St. Thomas More Lawyer's Guild under its president, Robert J. 
