## St. Mary's OB

**Continued from Page 1** voting to close St. Mary's obstetrical service.

Despite the fact that the number of deliveries does not reach the criterion, St. Mary's can still deliver a high quality OB service to the public at a considerably lower cost than any other hospital in Rochester, St. Mary's officials point out

It has been reported by the planning agency on several occasions that there are unneeded obstetrical beds in all Rochester hospitals. Therefore an option that St. Mary's officials feel would be a better decision for the FLSHA **Executive Committee would** be to decertify the unnecessary beds in each hospital rather than to close a unit in which the cost to deliver the service is the lowest

Apart from the cost issue, which is a real one, the primary issue in the question of closure is that St, Mary's Hospital is the only religious-sponsored obstetrical service in Rochester. Therefore, it is the only one which gives an option for those persons who wish to select a hospital which believes that the rights and dignity of every man must be protected and defended with the utmost care, from the moment of conception throughout the total life and death process St. Mary's turther endorses and fosters the ideals and values or tamily life.

To discontinue the obstetrical service at St Mary's appears'to leave out the element of pluralism in health planning, and if adopted, the people of Monroe County would be forged to accept one set of values in an important aspect of health care, which hospital officials see as a further erosion of people's

St. Mary's officials point

out that every other hospital duplicates one another with offering abortions, tubal ligations and sterilization procedures as part of their obstetrical service. None of these procedures are true obstetrical services since they are directly opposed to the definition of obstetrics which is the "science or art of assisting a woman in partuition, the bring forth of young in childbirth.

St. Mary's officials cannot accept the portion of the 'Guidelines for Perinatal Services" approved by the FLHSA and which state that "Any hospital which intends to provide full obstetrical coverage must provide for family planning, sterilization and abortion. St. Mary's officials point out that several regiona planning agencies in the state appear to discriminating against the obstetrical service Catholic hospitals by making a guideline similar to this one a criterion for continuation of OB service.

# Sister Eva Marie Dies

Sister Eva Marie Schreiner, who abandoned a career in banking to become a Sister of St. Joseph, died May 14, 1977, after a brief

She was the first director of development at Nazareth College, when the office was set up in 1956, and since 1971 had been a consultant in planning and develop-

The Mass of Christian Burial was celebrated yesterday morning in the Motherhouse chapel.

Before entering the religious life, Sister Eva Marie was an assistant trust officer in charge of the tax department at Security Trust. One of her responsibilities was the George Eastman estate, but that came to her by accident in an alphabetical division of accounts, she used to explain. She founded the Catholic Girl Scouts of Rochester, establishing the first troop in St. Boniface parish: She was president of the Chamber of Commerce Women's Council, of the Catholic Women's Club and the Nazareth Academy Alumnae Association, and she served on the board of Genesee Settlement House.

She prepared for her secular career at the University of Rochester and through the American Institute of Banking. After entering the Sisters of St. Joseph in 1943, she earned a BA degree at Nazareth College and an MS in guidance and vocational counseling from Fordham University. She became director of placement and vocational counseling at the

While director of development, Sister Eva Marie served as adviser to the alumnae association and the Nazareth College Guild, organized the Parents' Association, Association, established an annual giving program and developed a student recruiting program at the time of her death.
