St. Ann's Notes 105 Years

The statue of St.: Ann and the Blessed Virgin which once graced the tower of St. Ann's Home when that facility was located on Lake Avenue, has been recently refinished and is now standing on the grounds of Ann's Home/The Heritage on Portland Avenue.

In recent dedication ceremonies, Sister Marie Michelle, administrator of the geriatric care institution, recounted the history of St. Ann's for the assembly.

She noted that Mother Hieronymo, in 1872, at Bishop McQuaid's request, established the facility which one day would become St. Ann's. This facility was opened as a boarding home for orphan girls too old to remain in an orphanage, but too young to be left on their own resources. In the Home of Industry, located on Edinburgh Street, these young women learned the trades that would enable them to support themselves.

Over the years, this facility moved several times, and, as public education provided for the training of young ladies, the Sisters of St. Joseph changed their emphasis from teaching the young to caring for aged and infirm

Knowing the care of the elderly would be a continuing and growing need, Bishop McQuaid changed the name of the Home of Industry to St. Ann's Home for the Aged in 1904 made plans for a new edifice at 1911 Lake Ave., which would serve both men and women.

This building, complemented by a north wing

in 1912 and a south wing in 600 residents and patients 1931 served the needs of the elderly for many years.

In October 1962, St. Ann's moved to its present location on Portland Avenue. Dedication ceremonies for the 354-bed, 10-story facility with connecting chapel were held in May 1963.

In 1973 an additional 19story, 237-apartment building called The Heritage was annexed to the home. The Heritage is designed for the fragile elderly in need of supportive and protective services to enable them to remain independent as long as possible.

Sister Marie Michelle noted at the ceremonies for the dedication of the statue to the patroness of the elderly, that seeing the figure will remind the nearly


not only of St. Ann's past, but of the role St. Ann's Home/The Heritage now plays in the entire community by offering such a broad-based service to both Catholics and non-Catholics alike.
