Budget Priorities Scrutinized by DPC

The Diocesan Pastoral Council (DPC) discussed diocesan priorities proposed by the Ministerial Review Committee (MRC) at its meeting Saturday at Becket Hall, and, in its own ranking, proposed changes.

The priorities will be used by the MRC for analysis of the upcoming diocesan budget. The committee will take the DPC's comments and ranking into consideration.

Much of the DPC's discussion, which was more than one hour long, concerned liturgy and the first priority, education.

Father John Mulligan noted that liturgy is "where we really gather our parish community together," and that liturgy should be ranked higher than the sixth position given by the MRC.

Beth Stefano of Tompkins-Tioga agreed, noting that some people sitting in the pews are unchurched, as they are "not being reached by the liturgy." Sister Josepha Kennedy, an MRC member, said that the committee ranked liturgy sixth because it felt that liturgy is "already somewhat well taken care of"

During discussion of the "Education" priority, MRC members pointed out that they discussed calling the category "Growth in Leadership," or having categories for education and for leadership.

A few members, including Father Charles Latus, Our Lady of Mercy co-pastor, questioned the need to make education the first priority, noting the extensive efforts already expended on education. Father Latus said that the continued emphasis on education is "making it very difficult to see and address other concerns."

In its own ranking of the categories, the DPC moved liturgy up to the third position. The DPC's ranking was Education, the Unchurched, Liturgy, Neighborhood Ministry, Sacredness of Life, Small

Communities and Structure in Service of Ministry.

Discussing it for the third time, the DPC committees offered opinions on the proposal from St. Michael's, Rochester, to limit bingo games.

Sister Mary Jean Smith reported that the Teaching Mission Committee recommended that action to limit games be taken on the regional rather than diocesan level. The Worship and Life Committee, Gail Raymond noted, suggested that parishes find other methods of fund raising, to reduce dependence on bingo games. The issue will remain with the DPC Executive Committee.

Betty Anderson and John Crowe, diocesan candidates to the Region II meeting to elect delegates to the USCC Advisory Council, reported to the DPC. Crowe, who was elected to the council, noted that it was not "a national pastoral council," but that it has been influential. He reported that the Campaign for Human Development and approval

The team offering the retreat will be Ted Auble, Mary Jo Brach, Joe Kelly and Sister Barbara Moore, who is acting as convenor for the team.

of Communion in the hand were issues which began in the council.

Crowe said that he considers his election "as an honor and a challenge," and that he is "looking forward to this experience."

Mrs. Anderson reported on the meeting, and that 18 at-large council memberships are yet to be-filled. Following the presentations, Father Mulligan offered a

resolution calling for Bishop Hogan to see if he can get Mrs. Anderson appointed an at-large 'member. The resolution was approved by a unanimous voice vote.

Two items placed on the agenda by the Teaching Mission Committee, a proposed diocesan tuition policy and a philosophical statement on religious education, were taken back to committee.

The recommendations on tuition included provisions for a minimum tuition of \$200 per family and for parishes to provide assistance to parishioners attending school in another parish. Sister Mary Jean, committee chairperson, explained that the \$200 figure was not a definite one.

Dr. Andrew Molloy, Chemung-Schuyler, questioned the fact that consolidations were not mentioned in the proposed policy. Father Latus noted that income tax implications, currently being discussed by the federal government, need to be considered. Other members questioned items in the proposal, and Sister Mary Jean said that the committee would study the issue further.

The proposed philosophical statement on religious education was criticized for its characterization of public education, and also will be studied further by the committee.
